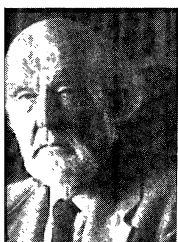


## LAA: 50 Update

## Interlibrary Loan Vouchers

LAA members will be aware that the AACOBS' recommendation that a standard charge of \$6 be made for supply of inter-library loans and photocopies was introduced and effective from 1 July 1987.

The LAA did request AACOBS to defer the charges until such time as a study on the likely impact could be taken (*InCite* vol 8 no 7 p.12), however AACOBS did not accede to this request.

Because of the introduction of the \$6 charge the Association is now producing a \$6 voucher. These may be purchased from the Association's Head Office. A book of fifty \$6 vouchers costs \$312. The handling charge for \$6 vouchers has been increased to \$12 as there has been no increase in the handling charge since 1982 despite rising costs in the processing of voucher orders and the maintenance of the system.

One dollar and \$3 vouchers may also continue to be purchased from the Association

## Public Lending Right

On 2 July, the Australian Society of Authors held a small function to celebrate the Public Lending Right Act which came into operation on 1 July 1987.

The function was addressed by the former Minister for Arts, Heritage and Environment, Barry Cohen, who noted that while the scheme had been operating for some years, its continued existence was assured under the legislation.

Prepayment for all voucher purchases is required, however the Association is happy to issue a proforma invoice should you experience difficulties in providing payment without an invoice.
