# Recognition for school community libraries

Following on from the success of the school community library program in South Australia since its inception in 1977, ALIA's South Australian Branch is initiating an annual award for school community libraries in the State.

The Branch intends that the award — named the Val Gauld School Community Library Award — be granted annually for a program designed to enhance, for both the public and school clients, the services offered in school community libraries in South Australia.

South Australia now has more than forty school community libraries, servicing mainly rural populations of 3000 or fewer. The Val Gauld School Community Library Award recognises the major contribution made to the program by Val Gauld, Executive Officer of the School Community Libraries Committee for many years.

Adelaide-based publisher Auslib Press is sponsoring the 1989 award, the winner of which will be announced at the end of the year.



### **Queensland Branch**

Major branch activities during September and October included a copyright seminar, a seminar on award restructuring, a cataloguing seminar, and a transition-to-work seminar for QUT librarianship students.

The proposed review of education for librarianship has received broadbased support from the Queensland library community. Sufficient funds have been promised to start work on the survey. Branch Council resolved to give the market research firm the go-ahead despite a funding shortfall of \$1500. General Council and the Executive must be lobbied again to gain sufficient funds to complete the survey. All Branch Council positions have been filled for 1990. No positions were contested.

The working party to establish feasibility of a 'local presence office' here has met and deliberated. Yes! of course we can benefit significantly from such a service. How will we get the money?

The Atlas of Queensland libraries is going to be published by February 1990— the Promotion and Publicity Committee said so. I'm sure it will be a significant publication to boost Year of the Reader programs.

Future reports will bring industrial relations news as the Branch begins a review of salaries for library workers in Queensland.

# Qualified librarians issue resolved

t their recent meetings, the National Advisory Committee on Library Services for People with Disabilities and the Committee of Chairmen of National, State and Territory Advisory Committees on Library Services for People with Disabilities passed the following resolution:

When a position becomes vacant in libraries specifically serving people with disabilities with work involving book selection (for stock) advising and/or selection of materials for readers, and bibliographic tasks, the position should be filled by a qualified librarian.

The basis for this resolution was information obtained from a survey conducted by the National Library of Australia of the number of qualified librarians in libraries serving blind and visually impaired people. The survey indicated that 78.4 per cent of staff with these tasks were not qualified librarians.
