## ALIA and the Australian Libraries Summit

#### InCite series

The following is a continuation of the article begun in the last issue of *InCite* (27 November) on the implementation of Summit resolutions related to school libraries. It is extracted from an article in *Orana* 25(3), August 1989.

#### **Resolution PP7**

That strategies for the further development of cooperative networks between school and other libraries be formulated by education authorities and library authorities

#### **Resolution PP8**

That ALIA/ASLA lobby education authorities to implement the ALIA policy on professional qualifications for teacherlibrarians.

- (a) Gather information on current position here and in the other States in relation to professional staffing in primary school Library Resource Centres (by December 1989).

- (a) Gather information from the tertiary institutions as to what units they

provide for primary teachers in librarianship in undergraduate, graduate and postgraduate courses.

- (b) Collate information and document what is available.
- (c) Prepare the submission to be given to the tertiary institutions based on the information received.

#### Time line

On-going, July to December 1989.

#### **Resolution PP9**

That ALIA/ASLA in each State review ways of bringing teacher—librarians into more professional contact with colleagues in other library sectors.

#### **Resolution PP10**

That ALIA/ASLA develop and promulgate statements on the role of the teacherlibrarian and the role and functions of school libraries to the State education and non-government education authorities and teacher training institutions.

#### Response

 The ALIA School Libraries Section (WA Group) will prepare and publish a booklet that collects relevant statements of roles and functions, and provides an analysis of them. ### Other Summit resolutions relating to school libraries

#### **Resolution CCI**

That existing methods of monitoring new technology nationally or within States be explored with a view to developing an effective method of monitoring and disseminating information on the impact of new technologies for library development.

## NATIONAL COLLECTING INSTITUTIONS BUDGETS

In the recent Federal Budget the following was given for the estimated outlays and staffing for 1989–90:

These projected outlays represent Federal Government funding and do not include revenue generated by the institutions themselves.

#### NATIONAL LIBRARY BUDGET

For 1989–90 the total budget outlay is \$43.051m. The net appropriation from the Government, \$33.744m, is up \$5.915m from the previous year.

The breakdown of the budget is:

Salaries and allowances	\$17.036m
Administrative expenditure	\$20.149m
Acquisitions	\$5.866m

The acquisition budget is an increase of 6.3% over the previous year to allow for inflation.

New policy proposals of \$2.75m have been approved; these consist of \$1.45m for an integrated library management system, \$1.1m for public facilities improvement on the ground floor, and \$0.2m for a feasibility study of a warehouse/document delivery facility.

Funds have also been provided for fire-safety works and for works, services and office accommodation.

Anyone wanting further details of the National Library's programs and sub-programs can find them in the budgetrelated paper 8.2 — i.e. the explanatory notes for the Department of Arts, Sport, the Environment, Tourism and Territories. The section on the National Library occupies 31 pages, and details subprograms for Australian Collections and Services, General Collections and Services, Network Services, National Co-ordination, Public Programs, and Corporate Services.

#### **REVIEW**

This was released on 19 October with a covering letter from the Director-General, copies being sent to State and Territory librarians, university librarians and a number of others. The Review was initiated in April 1988 and went to the Minister in December 1988. It was carried out by a team consisting of Mr D. Gascoine (Department of Arts, Sport, the Environment, Tourism and Territories), Mr P. Pharaoh (Department of Finance) and Mr D. Toll (NLA).

The National Library Council is in broad agreement with the thrust of almost all of the recommendations in the Review and will be discussing a detailed report on action to be taken about each recommendation at its next meeting.

The Review is generally supportive of the National Library, as the following extract from paragraphs 1.27 and 1.28 shows:

'In general (but with some qualifications set out below) the operations of the National Library are conducted in a reasonably efficient and effective way within the terms of the Library's goals and objectives. From our observations we believe that the tasks are appropriately defined and are understood by staff and that the work is diligently performed.'
