include Kim See Ch'ng, Librarian of the Institute of Southeast Asian Studies in Singapore, Primo Afeau, Principal Legal Officer of the Solomon Islands Attorney General's Department, and Margaret Gibson Smith, Medical Librarian of the University of Auckland.

The conference is generously supported by organisations and businesses. Six librarians from the Pacific Islands region have been brought to Australia through AIDAB's International Seminars Support Scheme. The Commonwealth Attorney General opens the program and his Department has sponsored a speaker representing the Pacific States.
