

CEMETERIES ORDINANCE 1966

No. 46 of 1966

An Ordinance to amend the *Cemeteries Ordinance*
1952-1964

[Assented to 2nd December, 1966.]

BE it ordained by the Legislative Council for the Northern Territory of Australia, in pursuance of the powers conferred by the *Northern Territory (Administration) Act* 1910-1965, as follows:—

Short title
and citation

1.—(1.) This Ordinance may be cited as the *Cemeteries Ordinance* 1966.

(2.) The *Cemeteries Ordinance* 1952-1964 is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Cemeteries Ordinance* 1952-1966.

Commencement

2. This Ordinance shall come into operation on the date on which the *Cemeteries Ordinance* 1952 comes into operation.*

By-laws

3. Section 13A of the Principal Ordinance is amended—

(a) by omitting from paragraph (c) the word “and”; and

(b) by inserting at the end thereof the following word and paragraph:

“; and (e) prescribing the fee or charge in respect of a service or facility provided under this Ordinance at that cemetery.”.

4. Section 39 of the Principal Ordinance is repealed and the following sections are inserted in its stead:—

Administrator may
determine fees

“39. The Administrator may, by notice in the *Gazette*—

(a) determine fees or charges for the undertaking of a funeral at a cemetery in respect of which a curator has been appointed under the last preceding section; and

- (b) determine the fee or charge in respect of a service or facility provided under this Ordinance at such a cemetery.

"39A. The Administrator may grant annual licences to undertakers to undertake funerals in a cemetery in respect of which a curator has been appointed under section 38 of this Ordinance."

Licences

5 Section 40 of the Principal Ordinance is amended by omitting paragraphs (g) and (h) and inserting in their stead the following paragraphs:—

Regulations

"(g) prohibiting, except under licence granted by the Administrator, the undertaking of funerals, and the acceptance of fees for the undertaking of funerals, in a cemetery in respect of which a curator has been appointed under section 38 of this Ordinance;

"(h) prescribing the form of, the manner in which an application may be made for, and the fee payable in respect of, a licence referred to in the last preceding paragraph;"

6 The Schedule to the Principal Ordinance is repealed.

Repeal of the Schedule

7 The Principal Ordinance is amended as set out in the Schedule to this Ordinance.
