

# CONTROL OF ROADS ORDINANCE 1971

941

No. 42 of 1971

An Ordinance to amend the *Control of Roads Ordinance* 1953–1968 as amended by the *Control of Roads Ordinance* 1970 and the *Control of Roads Ordinance* 1969 and for other purposes

[Assented to 27 September, 1971]

**B**E it ordained by the Legislative Council for the Northern Territory of Australia as follows:—

1.—(1.) This Ordinance may be cited as the *Control of Roads Ordinance* 1971. Short title  
and citation

(2.) The *Control of Roads Ordinance* 1953–1968 as amended by the *Control of Roads Ordinance* 1970 and the *Control of Roads Ordinance* 1969 is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance as amended by this Ordinance may be cited as the *Control of Roads Ordinance* 1953–1971.

2.—(1.) The provisions of this Ordinance other than sections 5 and 6 shall come into operation on a date to be fixed by the Administrator by notice in the *Gazette*.\* Commencement

(2.) Sections 5 and 6 of this Ordinance shall be deemed to have come into operation on the date on which the *Control of Roads Ordinance* 1969 came into operation.†

3. Section 5 of the Principal Ordinance is amended by omitting the definition of “officer” and inserting in its stead the following definition:— Definitions

“ ‘officer’ means a person who—

(a) is appointed under section 7A of this Ordinance to be an officer; or

(b) is a member of the Northern Territory Police Force;”.

4. After section 7 of the Principal Ordinance the following section is inserted in Part II. :—

Officers

“7A.—(1.) The Administrator may appoint persons to be officers for the purposes of this Ordinance.

“(2.) A member of the Northern Territory Police Force is *ex-officio* an officer for the purposes of this Ordinance.”.

5. The title of the *Control of Roads Ordinance 1969* is amended by adding at the end thereof the words “, as amended by the *Control of Roads Ordinance 1970*”.

6. Section 1 of the *Control of Roads Ordinance 1969* is amended by omitting sub-sections (2.) and (3.) and inserting in their stead the following sub-sections:—

“(2.) The *Control of Roads Ordinance 1953-1968*, as amended by the *Control of Roads Ordinance 1970*, is in this Ordinance referred to as the Principal Ordinance.

“(3.) Section 1 of the *Control of Roads Ordinance 1970* is amended by omitting sub-section (3.).

“(4.) The Principal Ordinance as amended by this Ordinance may be cited as the *Control of Roads Ordinance 1953-1970*.”.
