FREEHOLD TITLES ORDINANCE 1971

No. 23 of 1971

An Ordinance to amend the Freehold Titles Ordinance 1962-1968 as amended by the Freehold Titles Ordinance 1970 and the Freehold Titles Ordinance (No. 2) 1970

BE it ordained by the Legislative Council for the Northern Territory of Australia as follows:-

1.—(1.) This Ordinance may be cited as the Freehold Short title and citation Titles Ordinance 1971.

- (2.) The Freehold Titles Ordinance 1962-1968 as amended by the Freehold Titles Ordinance 1970 and the Freehold Titles Ordinance (No. 2) 1970 is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance as amended by this Ordinance may be cited as the Freehold Titles Ordinance 1962-1971.
- 2. This Ordinance shall be deemed to have come into commencement operation on the first day of January, 1971.
- 3. Section 3 of the Principal Ordinance is amended by Definitions omitting the definition of "municipality".
 - 4. Section 14A of the Principal Ordinance is amended—
 - (a) by omitting from paragraph (a) of sub-section (1.) the words "within a municipality and is"; and
 - (b) by omitting from paragraph (b) of sub-section purchase price (1.) the words "land within a municipality and is".

- 7. Section 1 of the Freehold Titles Ordinance (No. 2) 1970 is amended—
 - (a) by omitting from sub-section (2.) the words "Freehold Titles Ordinance 1963-1969" and inserting in their stead the words "Freehold Titles Ordinance 1962-1968"; and
 - (b) by omitting from sub-section (4.) the words "Freehold Titles Ordinance 1963-1970" and inserting in their stead the words "Freehold Titles Ordinance 1962-1970".

Application

- 8.—(1.) Notwithstanding the amendments effected by sections 4 and 5 of this Ordinance, where, in respect of the grant of an estate in fee simple made after the commencement of the Freehold Titles Ordinance (No. 2) 1970 but before the commencement of the Freehold Titles Ordinance 1971 a purchase price would have been payable but for the commencement of this Ordinance and an amount has been paid in payment of all or part of that purchase price, that amount shall be retained by the Commonwealth.
- (2.) Paragraph (a) of section 14B of the Principal Ordinance as amended by this Ordinance applies, in respect of land that is not within the Municipality of Darwin, as well in respect of amounts paid after the date of commencement of the Freehold Titles Ordinance (No. 2) 1970 and before the date of commencement of the Freehold Titles Ordinance 1971 as in respect of amounts paid before the date of commencement of the Freehold Titles Ordinance (No. 2) 1970.
