LOCAL COURTS ORDINANCE (No. 2) 1970

An Ordinance to amend the Local Courts Ordinance 1941-1965 as amended by the Local Courts Ordinance 1970

[Assented to 8 December, 1970]

 B^E it ordained by the Legislative Council for the Northern Territory of Australia as follows:—

1.--(1.) This Ordinance may be cited as the Local Courts Short title and citation Ordinance (No. 2) 1970.

(2.) The Local Courts Ordinance 1941-1965 as amended by the Local Courts Ordinance 1970 is in this Ordinance referred to as the Principal Ordinance.

(3.) Section 1 of the Local Courts Ordinance 1970 is amended by omitting sub-section (3.).

(4.) The Principal Ordinance as amended by this Ordinance may be cited as the Local Courts Ordinance 1941-1970.

2. Section 5 of the Principal Ordinance is amended by Definitions omitting the definition of "the Territory" and inserting in its stead the following definition:----

"'the Territory' includes the Territory of Ashmore and Cartier Islands;".

3. Section 13 of the Principal Ordinance is amended by Appointment of officers adding at the end thereof the following sub-section:---

"(2.) A member of the Police Force of the Northern Territory has all the powers, and may perform all the duties and functions, of an assistant bailiff of a Local Court.".

4. The Principal Ordinance is amended as set out in the Amendments in relation to decimal currency Schedule to this Ordinance.
