An Ordinance to amend the *Motor Vehicles Ordinance* 1949–1967

[Assented to 1 May, 1968]

BE it ordained by the Legislative Council for the Northern Territory of Australia, in pursuance of the powers conferred by the Northern Territory (Administration) Act 1910-1967, as follows:—

Short title and citation

- 1.—(1.) This Ordinance may be cited as the *Motor Vehicles Ordinance* 1968.
- (2.) The Motor Vehicles Ordinance 1949-1967 is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Motor Vehicles Ordinance* 1949-1968.

Commencement

2. This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.

The Second Schedule

3. The Second Schedule to the Principal Ordinance is repealed and the following Schedule inserted in its stead:—
"THE SECOND SCHEDULE.

SCALE OF FEES PAYABLE FOR REGISTRATION OF MOTOR VEHICLES, FOR LICENCES AND FOR RENEWALS.

- "1.—(1.) Registration or renewal of registration of a motor vehicle, being a motor car, motor lorry, motor tractor or public motor vehicle, but not being a mobile crane—
 - (a) where the vehicle has pneumatic, semi-pneumatic rubber or super resilient tyres—
 - (i) motor car or public motor vehicle (other than a motor omnibus) at the rate of 37 cents per half hundredweight of its weight;
 - (ii) motor omnibus—at the rate of 54 cents per half hundredweight of its weight;
 - (iii) motor lorry or motor tractor-
 - (A) of weight not exceeding 40 hundredweight—at the rate of 37 cents per half hundredweight of its weight;
 - (B) of weight exceeding 40 hundredweight but not exceeding 80 hundredweight—at the rate of 37 cents per half hundredweight of its weight;
 - (C) of weight exceeding 80 hundredweight but not exceeding 120 hundredweight—at the rate of 38 cents per half hundredweight of its weight;
 - (D) of weight exceeding 120 hundredweight—at the rate of 38 cents per half hundredweight of its weight;

- (b) where the vehicle has non-pneumatic or solid tyres—at one and onequarter times the rate applicable to a similar vehicle having pneumatic tyres.
- "(2.) In the case of a motor lorry, motor tractor or a trailer, owned by a grazier or farmer, not being a company, used solely for the carting of his own produce or the requisites of his occupation, and not let r hire or for any reward, the fee for registration or renewal of registration of that motor lorry, motor tractor or trailer shall be one-half of the fee which would, except for this sub-clause, be applicable under this Schedule.
- "(3.) In the case of a motor lorry or a trailer owned by a person, not being a company, engaged on his own account, and not in association with more than two other persons, in mining, or in hunting or trapping buffaloes, crocodiles, kangaroos or dingoes, and used solely for the purposes of the owner's occupation, the fee for registration or renewal of registration of that motor lorry or trailer shall be one-half of the fee which would, except for this sub-clause, be applicable under this Schedule.
- "(4.) Notwithstanding anything contained in this Schedule, the fee for registration or renewal of registration of a motor tractor shall not, in any case, exceed Thirty dollars.
