POLICE AND POLICE OFFENCES **ORDINANCE 1978**

No. 31 of 1978

An Ordinance to amend the Police and Police Offences **Ordinance**

[Assented to 20 June 1978]

E it ordained by the Legislative Assembly for the Northern B Territory of Australia as follows:

- 1. This Ordinance may be cited as the Police and Police Offences Short title Ordinance 1978.
- 2. The Police and Police Offences Ordinance is in this Ordinance Principal referred to as the Principal Ordinance.

- 3. This Ordinance shall come into operation on a date to be fixed Commencement by the Administrator by notice in the Gazette.*
- 4. Section 63 of the Principal Ordinance is amended by adding at Malicious the end the following sub-sections:

- "(4) Where a justice makes an order under sub-section (1) requiring a person to pay a sum of money for compensation, the justice shall make and sign a minute or memorandum of the order.
- "(5) The minute or memorandum referred to in sub-section (4) may be registered in a court of competent jurisdiction.
- "(6) Upon registration under sub-section (5), the minute or memorandum becomes a record of the court with the same force and effect as a judgment of the court, and the like proceedings (including proceedings in bankruptcy) may be taken upon the minute or memorandum as if the order had been a judgment of the court in favour of the person entitled to receive the compensation.".
- 5. The Principal Ordinance is further amended as set out in the Amendments Schedule.
