

POLICE AND POLICE OFFENCES ORDINANCE 1978

119

No. 31 of 1978

An Ordinance to amend the *Police and Police Offences Ordinance*

[Assented to 20 June 1978]

BE it ordained by the Legislative Assembly for the Northern Territory of Australia as follows:

1. This Ordinance may be cited as the *Police and Police Offences Ordinance* 1978. Short title

2. The *Police and Police Offences Ordinance* is in this Ordinance referred to as the Principal Ordinance. Principal Ordinance

3. This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the *Gazette*.^{*} Commencement

4. Section 63 of the Principal Ordinance is amended by adding at the end the following sub-sections: Malicious injury to property

“(4) Where a justice makes an order under sub-section (1) requiring a person to pay a sum of money for compensation, the justice shall make and sign a minute or memorandum of the order.

“(5) The minute or memorandum referred to in sub-section (4) may be registered in a court of competent jurisdiction.

“(6) Upon registration under sub-section (5), the minute or memorandum becomes a record of the court with the same force and effect as a judgment of the court, and the like proceedings (including proceedings in bankruptcy) may be taken upon the minute or memorandum as if the order had been a judgment of the court in favour of the person entitled to receive the compensation.”.

5. The Principal Ordinance is further amended as set out in the Schedule. Amendments of various sections
