STOCK ROUTES AND TRAVELLING STOCK ORDINANCE 1969

No. 48 of 1969

An Ordinance to amend the Stock Routes and Travelling Stock Ordinance 1954–1963

[Assented to 27 November, 1969]

B E it ordained by the Legislative Council for the Northern
Territory of Australia as fells Territory of Australia as follows:—

1.—(1.) This Ordinance may be cited as the Stock Routes Short title and citation and Travelling Stock Ordinance 1969.

- (2.) The Stock Routes and Travelling Stock Ordinance 1954-1963 is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance as amended by this Ordinance may be cited as the Stock Routes and Travelling Stock Ordinance 1954-1969.
- 2. This Ordinance shall come into operation on a date to Commencement be fixed by the Administrator by notice in the Gazette.*
- 3. Section 5 of the Principal Ordinance is amended by Appointment of Chief Inspector omitting sub-sections (1.) and (2.) and inserting in their stead the following sub-sections:-

- "(1.) There shall be a Chief Inspector of Stock Routes, who shall be appointed by the Administrator.
 - "(2.) In the event of—

(a) the illness of the Chief Inspector;

- (b) the temporary inability of the Chief Inspector to perform the duties of his office;
- (c) the absence of the Chief Inspector from the Territory; or
- (d) the death, retirement or dismissal of the Chief Inspector, and pending the appointment of a new Chief Inspector,

the Administrator may appoint a person to be Acting Chief Inspector of Stock Routes during the illness, temporary inability or absence of the Chief Inspector, or following the death, retirement or dismissal of the Chief Inspector.".

Appointment of Superintendent, &c.

- 4. Section 8 of the Principal Ordinance is amended by omitting sub-section (1.) and inserting in its stead the following sub-section:—
- "(1.) There shall be a Superintendent of Stock Routes, who shall be appointed by the Administrator.".

Appointment of Registrar, &c.

- 5. Section 10 of the Principal Ordinance is amended by omitting sub-section (1.) and inserting in its stead the following sub-section:—
- "(1.) There shall be a Registrar of Stock Routes, who shall be appointed by the Administrator.".

Inspectors

- 6. Section 12 of the Principal Ordinance is amended—
 - (a) by omitting from sub-section (1.) the words "The Minister" and inserting in their stead the words "The Administrator"; and
 - (b) by omitting from sub-section (2.) the words "The Minister" and inserting in their stead the words "The Administrator".

Repeal of section 66 7. Section 66 of the Principal Ordinance is repealed.

Regulations

8. Section 67 of the Principal Ordinance is amended by omitting the words "The Administrator" and inserting in their stead the words "The Administrator in Council".

Amendments in relation to decimal currency 9. The Principal Ordinance is amended as set out in the Schedule to this Ordinance.
