

No. 30 of 1968

An Ordinance to amend the *Veterinary Surgeons Ordinance* 1960, and for other purposes

[Assented to 18 June, 1968]

BE it ordained by the Legislative Council for the Northern Territory of Australia, in pursuance of the powers conferred by the *Northern Territory (Administration) Act* 1910-1968, as follows:—

1—(1.) This Ordinance may be cited as the *Veterinary Surgeons Ordinance* 1968. Short title and citation

(2.) The *Veterinary Surgeons Ordinance* 1960 is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Veterinary Surgeons Ordinance* 1960-1968.

2 Section 14 of the Principal Ordinance is repealed and the following section inserted in its stead:—

“14. The Administrator shall appoint a person who holds an office, created under the *Public Service Act* 1922-1967, in the Animal Industry and Agriculture Branch, in the Northern Territory, in the Department of the Interior, to be Registrar under this Ordinance.” The Registrar

3 The Principal Ordinance is amended as set out in the Schedule to this Ordinance. Amendments in relation to decimal currency.

4 The purported exercise of a power or performance of a function under the Principal Ordinance, at any time during the period from and including the date of creation of the office of Director, Animal Industry and Agriculture Branch, in the Northern Territory, in the Department of Territories, to but not including the date of commencement of this Ordinance, by the person who was then purportedly appointed under section 14 of the Principal Ordinance, purporting to act as the Registrar Validation of certain actions

under the Principal Ordinance, shall be deemed to have been as valid and effectual as it would have been if he was then validly so appointed.
