## Regulations under the Forestry Ordinance 1959-1965

## AMENDMENTS OF THE FORESTRY REGULATIONS!

Interpretation

1. Regulation 3 of the Forestry Regulations is amended by inserting in sub-regulation (1.), after the definition of "depot", the following definition:—
"'forest products' means forest produce as defined in the Ordinance;".

Prescribed purposes, substances and articles 2. Regulation 8 of the Forestry Regulations is amended by omitting from paragraph (a) the words "manufacturing forest products, processing forest products," and inserting in their stead the words "manufacturing from forest products, processing forest products, conducting research, surveys, studies or other investigations in relation to forest products or the use of forest products or for ancillary purposes,".

Prohibition on taking etc. certain trees 3. Regulation 52 of the Forestry Regulations is amended by omitting the words "belonging to a class indicated by a botanical name in the following table:—" and inserting in their stead the words "being a tree or a part of a tree the botanical name of the species of which is specified in the following table:—".

- 4. Regulation 53 of the Forestry Regulations is amended—
- Minimum girth of certain trees permitted to be taken etc.
- (a) by omitting from paragraph (a) the word "or" (last occurring) and inserting in its stead the word "and"; and
- (b) by omitting paragraph (b) and inserting in its stead the following paragraph:—
  - "(b) if it is a tree or a part of a tree the botanical name of the genus or species of which is specified in the following table—the tree has, at a height of four feet three inches above the ground, a girth not less than that specified in the table opposite that botanical name:—

- 5. Regulation 62 of the Forestry Regulations is amended—
  - (a) by omitting the word "The" and inserting in its stead the words "Subject to the next succeeding sub-regulation, the"; and
  - (b) by adding at the end thereof the following sub-regulation:—
    "(2.) The last preceding sub-regulation does not prohibit the holder of a forest products licence from destroying, taking or moving a tree or part of a tree growing on the

licensed area where the tree has, at a height of four feet three inches above the ground, a girth of less than that specified in the table of paragraph (b) of regulation 53 of these Regulations opposite the botanical name of the genus or species of the tree."

## Amendment of Schedule

- 6. The Schedule to the Forestry Regulations is amended—
  - (a) by omitting from Form 7 the words "Class of timber" and inserting in their stead the words "Species or, where it does not have a specific name, genus of timber"; and
  - (b) by omitting from Form 19 the words "Species and Description" and inserting in their stead the words "Species or, where it does not have a specific name, genus of timber".
