

# DARWIN RADIO-TELEGRAPH STATION ORDINANCE 1929.\*

## An Ordinance relating to the Radio-Telegraphic Station at Darwin.

**W**HEREAS on the twenty-third day of February One thousand nine hundred and twenty-one the Governor-General, by Proclamation issued in pursuance of the *Northern Territory Acceptance Act 1910* and the *Northern Territory Crown Lands Act 1890* (an Act of the State of South Australia continued in force in the Northern Territory), reserved the area described in the Schedule to this Ordinance as a site for a Radio-Telegraphic Station: Preamble.

And whereas by an Agreement made on the twenty-eighth day of March One thousand nine hundred and twenty-two between the Commonwealth of Australia and Amalgamated Wireless (Australasia) Limited of Sydney in the State of New South Wales it was agreed (*inter alia*) that Amalgamated Wireless (Australasia) Limited should take over and operate certain existing Commonwealth Radio Stations, including the station erected on the site described in the Schedule to this Ordinance (hereinafter referred to as the Darwin Radio Station) at a valuation to be determined in accordance with the agreement:

And whereas Amalgamated Wireless (Australasia) Limited has taken over and is now operating the Darwin Radio Station in accordance with the terms of the Agreement:

And whereas it is desirable that the site of the Station should be vested in Amalgamated Wireless (Australasia) Limited for an estate in fee simple:

Be it therefore ordained by the Deputy of the Governor-General of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *Northern Australia Act 1926* as follows:—

1. This Ordinance may be cited as the *Darwin Radio-Telegraph Station Ordinance 1929*.\* Short title.

2. The land described in the Schedule to this Ordinance is hereby vested in Amalgamated Wireless (Australasia) Limited, of Sydney, in the State of New South Wales, for an estate in fee simple and the Governor-General may, if so requested by the company, issue to the company a Crown Grant of the land subject to any reservations required to be inserted in Crown Grants by the *Crown Lands Ordinance 1927*.

#### THE SCHEDULE.

Commencing at a point distant 157.3 links and bearing 332 degrees 6 minutes from the intersection of the south-eastern side of Hood-terrace with the south-western side of McMinn-street, town of Darwin, hundred of Bagot, county of Palmerston; thence on a bearing of 335 degrees 4 minutes 10 seconds for 485 links; thence on a bearing 224 degrees 34 minutes 15 seconds for 624.1 links; thence on a bearing of 134 degrees 34 minutes 15 seconds for 454.5 links; thence on a bearing of 44 degrees 34 minutes 15 seconds for 454.5 links to the point of commencement and containing an area of 2 acres 1 rood and 32 perches, more or less.
