

NORTHERN TERRITORY ELECTORAL DISTRICTS
REGULATIONS*

- Citation.

1. These Regulations may be cited as the Northern Territory Electoral Districts Regulations.
- Repeal.

2. The Northern Territory Electoral Districts Regulations (being Statutory Rules 1962, No. 95) are repealed.
- Definitions.

3. In these Regulations—
“North Australia Railway” means the railway between Darwin and Birdum;
“the town of Darwin” means the land in the Territory described in the Schedule to the Proclamation under the *Crown Lands Ordinance* 1931-1948 of the Territory published in the *Gazette* on the nineteenth day of January, One thousand nine hundred and fifty.
- Boundaries of Electoral Districts.

4. For the purposes of the election of members of the Legislative Council referred to in paragraph (d) of sub-section (2.) of section 4 of the *Northern Territory (Administration) Act* 1910-1962—
(a) the eight Electoral Districts referred to in section 4c of that Act shall be known as the Electoral District of Nightcliff, the Electoral District of Fannie Bay, the Electoral District of Port Darwin, the Electoral District of Arnhem, the Electoral District of Elsey, the Electoral District of Barkly, the Electoral District of Alice Springs and the Electoral District of Stuart, respectively; and
(b) the boundaries of each of those Electoral Districts are the boundaries respectively set out in the Schedule to these Regulations in relation to that Electoral District.

THE SCHEDULE Regulation 4.

BOUNDARIES OF ELECTORAL DISTRICTS

Name of Electoral District	Boundaries
Electoral District of Nightcliff	Commencing at the intersection of the centreline of Rapid Creek and the centreline of McMillan's Road; thence westerly by the centreline of McMillan's Road to its intersection with the centreline of Bagot Road; thence southerly by the centreline of Bagot Road to its intersection with the boundary of the town of Darwin; thence westerly northwesterly southwesterly northerly and northwesterly by that boundary to the mouth of Ludmilla Creek; thence by the sea coast generally northerly and northeasterly to the centreline of Rapid Creek; thence generally southerly by the centreline of Rapid Creek to the point of commencement.

Electoral District of Fannie Bay	Commencing at the intersection of the centreline of Mindil Beach Road and the centreline of Gilruth Avenue; thence northwesterly by the centreline of Mindil Beach Road and its prolongation to high water mark; thence west to low water mark; thence by low water mark generally northerly and northwesterly to a point west of East Point; thence east to the sea coast at East Point; thence generally easterly by the sea coast to the centreline of Ludmilla Creek being the boundary of the town of Darwin; thence by that proclaimed boundary southeasterly southerly northeasterly southeasterly and easterly to its intersection with the centerline of Bagot Road; thence southerly along the centreline of Bagot Road and southeasterly along the centreline of Snell Street and its prolongation southeasterly to its intersection with the centreline of Sadgroves Creek being the boundary of the town of Darwin; thence westerly and southerly along that boundary to a point east of the most eastern corner of Lot 1908; thence west to that corner; thence northwesterly and westerly along boundaries of Lot 1908 and Lot 1909 to a northern corner of Lot 1909; thence northwesterly to the eastern corner of Lot 2048; thence northwesterly and southwesterly by boundaries of that Lot to the prolongation of the centreline of Henry Street; thence northwesterly and westerly by that prolongation the centreline of Henry Street and its prolongation westerly to the centreline of the North Australia Railway; thence northerly by that centreline and northwesterly by the centreline of the old Vestey Spur-line to the centreline of Gilruth Avenue; thence generally southwesterly by that centreline to the point of commencement.
Electoral District of Port Darwin	Commencing at the intersection of the centreline of Mindil Beach Road and the centreline of Gilruth Avenue; thence generally northeasterly by the centreline of Gilruth Avenue to the centerline of the old Vestey Spur Line; thence southeasterly by that centreline and southerly by the centreline of the North Australia Railway to its intersection with the prolongation westerly of the centreline of Henry Street; thence easterly and southeasterly by that prolongation and the centreline of Henry Street and its prolongation southeasterly to the north-west boundary of Lot 2048; thence north-easterly and southeasterly by boundaries of that Lot to its eastern corner; thence southeasterly to a northern corner of Lot 1909; thence easterly and southeasterly by boundaries of Lot 1909 and Lot 1908 to the most eastern corner of Lot 1908; thence east to the centreline of Sadgroves Creek being the boundary of the town of Darwin; thence southerly along that boundary to low water mark; thence by low water mark generally southerly westerly northwesterly and northeasterly to a point west of the intersection of the prolongation northwesterly of the centreline of Mindil Beach Road and high water mark; thence east to that intersection; thence southeasterly by that prolongation and the centreline of Mindil Beach Road to the point of commencement and including all wharves jetties breakwaters and other erections contiguous to on or extending over the said low water mark.
Electoral District of Arnhem	Commencing at the intersection of the parallel 10 degrees 50 minutes south latitude with the meridian 138 degrees east longitude; thence south by that meridian to a point east of the mouth of the Roper River; thence west to a point south of the intersection of the sea coast of the Gulf of Carpentaria and a line east from the most eastern northeastern corner of Pastoral Lease 621; thence north to that intersection; thence west to that most eastern northeastern corner; thence by boundaries of the Arnhem Land Aboriginal Reserve westerly northerly westerly southerly westerly and northerly to the northeastern corner of Pastoral Lease 668; thence westerly along the northern boundary of Pastoral Lease 668 to the eastern boundary of Pastoral Lease 612; thence northwesterly northerly westerly northerly and westerly along northeastern eastern northern eastern and northern boundaries of Pastoral Lease 612 to the southeastern corner of Pastoral Lease

Gillen Trigonometrical Station; thence along the Heavitree Range on a line bearing 288 degrees 30 minutes true to the Mt. Gillen Trigonometrical Station; thence north on the local meridian to its intersection with a line west from the starting point; thence by that line east to the point of commencement.</p>
