# No. 70 of 1998

#### An Act to amend the Australian Formula One Grand Prix Act 1984.

[Assented to 3 December 1998]

The Parliament of South Australia enacts as follows:

#### Short title

1. (1) This Act may be cited as the Australian Formula One Grand Prix (South Australian Motor Sport) Amendment Act 1998.

(2) The Australian Formula One Grand Prix Act 1984 is referred to in this Act as "the principal Act".

#### Commencement

2. This Act will come into operation on a day to be fixed by proclamation.

#### Amendment of long title

3. The long title of the principal Act is amended by striking out "establish a corporation to be known as the "Australian Formula One Grand Prix Board" and substituting "make provision in relation to a corporation to be known as the "South Australian Motor Sport Board".

#### Substitution of s. 1

4. Section 1 of the principal Act is repealed and the following section is substituted:

#### Short title

1. This Act may be cited as the South Australian Motor Sport Act 1984.

#### Amendment of s. 3-Interpretation

5. Section 3 of the principal Act is amended-

(a) by striking out from subsection (1) the definition of "the Board" and substituting the following definition:

"Board" means the South Australian Motor Sport Board continued in existence under Part 2;;

(b) by striking out from subsection (1) the definitions of "declared area" and "declared period" and substituting the following definitions:

"declared area" means an area declared by the Minister by notice under Part 3 to be a declared area under this Act;

"declared period" means a period declared by the Minister by notice under Part 3 to be a declared period under this Act;;

- (c) by striking out from subsection (1) the definition of "grand prix insignia";
- (d) by striking out from subsection (1) the definition of "the logo" and substituting the following definition:

"logo" means a design (the copyright of which is vested in the Crown in right of the State) that is declared in the graphic standards manual to be a logo;;

(e) by striking out from subsection (1) the definitions of "official grand prix insignia", "an official symbol" and "official title" and substituting the following definitions:

"official insignia" means a logo, an official symbol or an official title;

"official symbol" means a combination of a logo and an official title;

"official title" means a name, title or expression that is declared to be an official title by or under section 28AA;;

- (f) by striking out from the definition of "relevant council" in subsection (1) "the declared area for any year" and substituting "a declared area";
- (g) by striking out from subsection (2) "grand prix";
- (h) by striking out subsections (3), (4) and (5) and substituting the following subsection:

(3) For the purposes of this Act, a motor sport event means a motor racing or other motor sport event and includes an event or activity promoted by the Board in association with the motor sport event.

#### Amendment of s. 4-Continuation of Board

6. Section 4 of the principal Act is amended by striking out subsection (1) and substituting the following subsection:

(1) The Australian Formula One Grand Prix Board continues in existence as the South Australian Motor Sport Board.

#### Amendment of s. 5-Membership of Board

7. Section 5 of the principal Act is amended by inserting after subsection (1) the following subsection:

(1a) At least one member of the Board must be a woman and at least one must be a man.

# Amendment of s. 10-Functions and powers of Board

8. Section 10 of the principal Act is amended—

- (a) by striking out from subsection (1)(a) "racing events are held in Adelaide" and substituting "sport events are held in the State";
- (b) by striking out from subsection (1)(b) "racing events in Adelaide" and substituting "sport events";
- (c) by striking out from subsection (1)(c) "to establish a motor racing circuit on a temporary basis and do all other" and substituting "to do all";
- (d) by striking out from subsection (1)(c) "motor racing event" and substituting "event";
- (e) by inserting before paragraph (a) of subsection (2) the following paragraph:
  - (aa) establish a motor racing circuit on a temporary basis; or;
- (f) by striking out from subsection (2)(d) "motor racing circuit established by the Board and charge and collect fees for admission to any such circuit" and substituting "event promoted by the Board and charge and collect fees for admission to any such event";
- (g) by striking out from subsection (2)(e) "motor racing";
- (h) by striking out from subsection (2)(f) "motor racing";
- (i) by striking out from subsection (2)(g) "motor racing";
- (j) by striking out from subsection (2)(h) "grand prix".

# Insertion of s. 10AA

9. The following section is inserted after section 10 of the principal Act:

# Non-application of Government Business Enterprises (Competition) Act 1996

**10AA.** The Government Business Enterprises (Competition) Act 1996 does not apply to the Board or to any activity of the Board.

# Amendment of s. 11-Board may control and charge fee for filming, etc., from outside circuit

10. Section 11 of the principal Act is amended by striking out subsection (1) and substituting the following subsection:

(1) Except with the consent of the Board, no person is entitled to make, for the purpose of profit or gain, at or from a place outside a circuit at which a motor sport event promoted by the Board takes place, any sound recording or television or other recording of moving pictures of the event or any part of the event.

#### Amendment of s. 19—Reports

11. Section 19 of the principal Act is amended by striking out subsection (1) and substituting the following subsection:

(1) The Board may, on or before 30 September in every year, forward to the Minister a report on the work and operations of the Board for the financial year ending on the preceding 30 June.

#### Substitution of heading

12. The heading to Part 3 of the principal Act is repealed and the following heading is substituted:

# SPECIAL PROVISIONS RELATING TO MAJOR MOTOR SPORT EVENTS.

#### Amendment of s. 20-Minister may declare area and period

13. Section 20 of the principal Act is amended-

(a) by striking out subsection (1) and substituting the following subsection:

(1) The Minister may, on the recommendation of the Board, in respect of a motor sport event promoted by the Board, by notice published in the *Gazette*, declare—

- (a) a specified area (consisting of public road or parkland, or both) in Adelaide to be a declared area under this Act for the purposes of the event; and
- (b) a specified period (not exceeding five days) to be a declared period under this Act for the purposes of the event.;
- (b) by inserting after subsection (2) the following subsection:

(3) The Minister may only make a declaration under subsection (1) in respect of one motor sport event per financial year.

# Amendment of s. 21-Board to have care, control, etc., of declared area for relevant declared period

14. Section 21 of the principal Act is amended-

- (a) by striking out from subsection (1) "the declared area for any year shall vest in the Board for the declared period for that year" and substituting "a declared area for a motor sport event vests in the Board for the declared period for that event";
- (b) by striking out from subsection (2) "the declared area for any year that is public road shall cease to be public road for the declared period for that year" and substituting "the declared area that is public road ceases to be public road for the declared period";
- (c) by striking out from subsection (2a) "for any year the Board opens any road within the declared area for that year" and substituting "the Board opens a road within the declared area".

15. Section 22 of the principal Act is amended by striking out from subsection (1) "the declared area for any year" and substituting "a declared area for a motor sport event".

# Amendment of s. 23—Board to consult and take into account representations of persons affected by operations

16. Section 23 of the principal Act is amended—

- (a) by striking out from subsection (1)(a)(i) "the declared area for any year" and substituting "a declared area";
- (b) by striking out from subsection (1)(a)(ii) "the declared area for any year" and substituting "a declared area".

### Amendment of s. 24-Certain land taken to be lawfully occupied by Board

17. Section 24 of the principal Act is amended-

- (a) by striking out from subsection (1) "the declared area for any year" and substituting "a declared area for a motor sport event";
- (b) by striking out from subsection (1) "the declared period for that year" and substituting "the declared period for that event";
- (c) by striking out from subsection (2) "the declared area for any year for a period not falling within the declared period for the year" and substituting "a declared area for a period not falling within the relevant declared period";
- (d) by striking out from subsection (3) "the declared area for any year" and substituting "a declared area".

#### Amendment of s. 25-Non-application of certain laws

18. Section 25 of the principal Act is amended—

- (a) by striking out from subsection (1) "the declared area for any year during the declared period for that year" and substituting "a declared area for a motor sport event during the declared period for that event";
- (b) by striking out from subsection (2) "the declared area for any year" and substituting "a declared area";
- (c) by striking out from subsection (3) "the declared area for any year during the declared period for that year" and substituting "a declared area for a motor sport event during the declared period for that event".

## Amendment of s. 27-Power to remove vehicles left unattended within declared area

19. Section 27 of the principal Act is amended by striking out from subsection (1) "the declared area for any year during the declared period for that year" and substituting "a declared area for a motor sport event during the declared period for that event".

#### Substitution of s. 28

20. Section 28 of the principal Act is repealed and the following sections are substituted:

#### Board may conduct activities under other name

28. The Board may, if it so determines, conduct its activities or any part of its activities not under the name the South Australian Motor Sport Board but under—

- (a) the name "Adelaide 500 Board"; or
- (b) the name "Sensational Adelaide 500 Board"; or
- (c) any name prescribed by regulation.

#### **Declaration of official titles**

**28AA.** (1) The following are declared to be official titles for the purposes of this Act (whether appearing or used in full or abbreviated form or alone or in combination with other words or symbols):

- (a) the expressions "Adelaide 500", "Sensational Adelaide 500", "Classic Adelaide" and "Race to the Eagle" where the expressions can reasonably be taken to refer to a motor sport event;
- (b) the expression "Adelaide Alive" where the expression can reasonably be taken to refer to an event or activity promoted by the Board;
- (c) any other name, title or expression declared by the Board by notice in the *Gazette* in respect of a particular event or activity promoted by the Board.

(2) The Board must not make a declaration under subsection (1)(c) without the consent of the Minister.

#### Amendment of s. 28A-Special proprietary interests

21. Section 28A of the principal Act is amended—

- (a) by striking out subsection (1) and substituting the following subsection:
  - (1) The Board has a proprietary interest in-
  - (a) its name; and
  - (b) any other name adopted by the Board pursuant to a determination under section 28; and
  - (c) all official insignia.;
- (b) by inserting before paragraph (a) of subsection (2) the following paragraph:
  - (aa) uses a name in which the Board has a proprietary interest under this section for the purpose of promoting the sale of goods or services or the provision of any benefits; or;
- (c) by striking out from subsection (2)(a) "grand prix";

- (d) by striking out from subsection (2)(b) "grand prix";
- (e) by striking out from subsection (3) "grand prix".

### Amendment of s. 28B-Seizure and forfeiture of goods

22. Section 28B of the principal Act is amended by striking out from subsection (1)(a) "grand prix".

#### Insertion of s. 29

23. The following section is inserted after section 28B of the principal Act:

## Transfer of property

29. (1) The Minister may, by instrument in writing, transfer an asset, right or liability of the Board to an agent or instrumentality of the Crown specified in the instrument.

(2) An instrument under subsection (1) may make other provisions that in the opinion of the Minister are necessary or expedient in connection with the relevant transfer.

(3) The Registrar-General or another authority required or authorised under a law of the State to register or record transactions affecting assets, rights or liabilities, or documents relating to such transactions, must, on application under this section, register or record in an appropriate manner the transfer of an asset, right or liability under this section.

#### Amendment of s. 30-Regulations

24. Section 30 of the principal Act is amended—

- (a) by striking out from subsection (2)(b), (c), (d), (e) and (g) "the declared area, or part of the declared area, for any year" wherever occurring and substituting, in each case, "a declared area, or part of a declared area, for a motor sport event";
- (b) by striking out from subsection (2)(f) "the declared area for any year and provide for the exclusion or expulsion of persons misbehaving within the" and substituting "a declared area for a motor sport event and provide for the exclusion or expulsion of persons misbehaving within a".

# Repeal of schedule

25. The schedule of the principal Act is repealed.

#### Transitional provision

26. The South Australian Motor Sport Board will have an 18 month financial year commencing on 1 January 1998 and ending on 30 June 1999 (and thereafter will have 12 month financial years commencing on 1 July in each year).
