An Act to amend the Lottery and Gaming Act 1936.

[Assented to 9 March 1995]

The Parliament of South Australia enacts as follows:

Short title

1. (1) This Act may be cited as the Lottery and Gaming (Miscellaneous) Amendment Act 1995.

(2) The Lottery and Gaming Act 1936 is referred to in this Act as "the principal Act".

Commencement

2. (1) Subject to subsection (2), this Act will come into operation on assent.

(2) Section 3 of this Act will be taken to have come into operation on 30 November 1994.

Amendment of s. 9-Exemptions from Act

3. Section 9 of the principal Act is amended by inserting after its present contents (now to be designated as subsection (1)) the following subsection:

(2) For the purposes of subsection (1)(d), payment of a membership fee to become a member of an association will, if membership entitles the member to participate (at no further cost) in a lottery, be taken to be payment of an entrance fee for participation in the lottery.

Substitution of s. 20

4. Section 20 of the principal Act is repealed and the following section is substituted:

Suspension or cancellation of licence

20. (1) The Minister may, by written notice to the holder of a licence-

(a) cancel the licence if the holder of the licence obtained the grant of the licence improperly; or

(b) cancel the licence or suspend it for a specified period or until further notice, if the holder of the licence has contravened a provision of this Act or a condition of the licence.

(2) A notice of suspension under subsection (1) may specify action to be taken by the licence holder to remedy any breach of this Act or the licence conditions.

Amendment of s. 57—Soliciting totalizator investments

5. Section 57 of the principal Act is varied by inserting after its present contents (now to be designated as subsection (1)) the following subsections:

(2) The Minister may, by notice published in the *Gazette*, exempt a racing club that has been registered under the *Racing Act 1976* from the operation of this section.

(3) An exemption granted under this section only operates in relation to race meetings lawfully held by the club named in the exemption.

(4) An exemption under this section may be given subject to conditions specified in the notice.

(5) The Minister may, by notice published in the *Gazette*, vary or revoke an exemption or a condition of an exemption under this section or impose a further condition.

(6) A club to which an exemption under this section applies must not contravene, or fail to comply with, a condition of the exemption.

Penalty: Division 6 fine.

Substitution of s. 75

6. Section 75 of the principal Act is repealed and the following section is substituted:

Occupying a common gaming-house

75. (1) A person who is the occupier of a common gaming-house is guilty of an offence.

Penalty: Division 4 fine or division 6 imprisonment.

(2) In proceedings for an offence under this section it will be presumed, in the absence of proof to the contrary, that the defendant knew that the house, office, room or place was being used as a common gaming-house.

Transitional

7. The amendment effected by section 3 of this Act does not invalidate or make unlawful a lottery opened before the commencement of that section.

Further amendments of principal Act

8. The principal Act is further amended as set out in the schedule.
