An Act to amend the Lottery and Gaming Act,
1936-1963.

[Assented to 30th October, 1964.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Lottery and Gaming Act Amendment Act, 1964" and shall come into operation on a day to be fixed by Proclamation. Short titles.
- (2) The Lottery and Gaming Act, 1936-1963, as amended by this Act, may be cited as the "Lottery and Gaming Act, 1936-1964".
- (3) The Lottery and Gaming Act, 1936-1963, is hereinafter referred to as "the principal Act".
2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act. Incorporation.
3. Subsection (1) of section 40 of the principal Act is amended— Amendment of principal Act, s. 40—
 - (a) by striking out the words "one pound" in paragraph (a) thereof and inserting in lieu thereof the words "one and one half"; and Payment of commission on bets and returns.
 - (b) by inserting at the end of paragraph (a) thereof the following proviso :—

"Provided that in respect of any bet referred to in this paragraph which has been made by a bookmaker prior to the commencement of the

Lottery and Gaming Act Amendment Act, 1964,
the commission shall be one per centum of the
moneys so paid or payable to him in respect of
such bet."

4. Subsection (2) of section 41 of the principal Act is amended—

- (a) by striking out paragraph (a) thereof ;
- (b) by inserting after the word "made" first occurring in paragraph (d) thereof the passage "prior to the commencement of the Lottery and Gaming Act Amendment Act, 1964" ;
- (c) by inserting after paragraph (d) thereof the following paragraph :—
 - (d1) five-sixths of the commission on all bets made after the commencement of the Lottery and Gaming Act Amendment Act, 1964, on racecourses on horse races held within the State, and one-sixth of the commission on all bets made after such commencement on racecourses on horse races held outside the State shall be divided among the racing clubs in proportion to the amounts of such bets made at race meetings held by each club ;
- (d) by inserting after the word "grounds" in paragraph (e) thereof the passage "prior to the commencement of the Lottery and Gaming Act Amendment Act, 1964" ;
- (e) by inserting after paragraph (e) thereof the following paragraph :—
 - (e1) five-sixths of the commission on all bets made on trotting grounds after the commencement of the Lottery and Gaming Act Amendment Act, 1964 (not being bets on horse races held outside the State) and one-sixth of the commission on all bets made on trotting grounds after such commencement (being bets on horse races held outside the State) shall be divided among the trotting clubs in proportion to the amounts of the bets made at trotting meetings held by each club ;

- (f) by inserting after the word “made” first occurring in paragraph (f) thereof the passage “prior to the commencement of the Lottery and Gaming Act Amendment Act, 1964,” ;
- (g) by inserting after paragraph (f) thereof the following paragraph :—
 - (f1) five-sixths of the commission on all bets made after the commencement of the Lottery and Gaming Act Amendment Act, 1964 on coursing events shall be divided among the coursing clubs in proportion to the amounts of the bets made on coursing events held by each club ;
- (h) by inserting before the word “all” in paragraph (g) thereof the words “the balance of any such commission and”.
