AN ORDINANCE for the Limitation of Actions and Suits relating to Real Property and for Simplifying the Remedies for Trying the Rights thereto.

WHEREAS a certain Act of Parliament was passed in the First Preamble Year of the Reign of Her present Majesty intituled "An Act to amend an Act of the Third and Fourth years of His late Majesty intituled 'An Act for the Limitation of Actions and Suits relating to Real Property and for Simplifying the Remedies for Trying the Rights thereto'" and whereas it is expedient to adopt and apply the said recited Act of Parliament in the administration of justice in the Province of South Australia and its Dependencies inasmuch as the Statute thereby amended is in force in this Province:

BE IT THEREFORE ENACTED BY HIS EXCELLENCY the Governor of South Australia with the advice and consent of the Legislative Council thereof That the said recited Act of Parliament and every clause 1 Vict. c. 28 adopted in provision the administration of
