An Act to amend the Parliamentary Salaries and Allowances Act, 1965-1974, the Constitution Act, 1934-1976, the Industries Development Act, 1941-1977, the Land Settlement Act, 1944-1974, the Public Accounts Committee Act, 1972-1974, and the Public Works Standing Committee Act, 1927-1975.

[Assented to 2nd March, 1978]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

PRELIMINARY

Short title.

1. This Act may be cited as the "Statutes Amendment (Remuneration of Parliamentary Committees) Act, 1978".

Commencement. 2. This Act shall come into operation on a day to be fixed by proclamation.

AMENDMENT OF PARLIAMENTARY SALARIES AND ALLOWANCES ACT

4. (1) The Parliamentary Salaries and Allowances Act, 1965-1974, is, Short uten in this Part, referred to as "the principal Act".

(2) The principal Act, as amended by this Act, may be cited as the "Parliamentary Salaries and Allowances Act, 1965-1978".

- 5. Section 5 of the principal Act is amended—
 - (a) by striking out subsections (1) and (2) and inserting in lieu thereof the following subsection:—

(1) At intervals of not more than three years, the Tribunal shall, after such inquiry as it thinks necessary—

(a) determine what remuneration should be paid to Ministers of the Crown and officers and members of Parliament;

and

- (b) determine what, if any, remuneration should be paid respectively to the chairman and members of each of the following committees (including any such members who are not members of Parliament):—
 - (i) the Industries Development Committee;
 - (ii) the Joint Committee on Subordinate Legislation;
 - (iii) the Parliamentary Committee on Land Settlement;
 - (iv) the Parliamentary Standing Committee on Public Works;
 - (v) the Public Accounts Committee;
 - (vi) the Select Committees of either or both Houses of Parliament,

in addition to the remuneration (if any) otherwise payable to them under this Act.;

and

- (b) by striking out from paragraph (a) of subsection (3) the passage "to Ministers of the Crown and to officers and members of Parliament" and inserting in lieu thereof the passage "under this Act".
- 6. Section 9 of the principal Act is amended—
 - (a) by striking out from subsection (1) the passage "or of any recommendation";

(b) by striking out from subsection (1) the passage "or recommendation"; and

Amendment of principal Act, s. 9— Tribunal may prepare report on a determination and Treasurer shall cause such report to be laid before Parliament.

(c) by striking out from subsection (2) the passage "or recommendation".

7. (1) The Constitution Act, 1934-1976, is, in this Part, referred to as "the principal Act".

(2) The principal Act, as amended by this Act, may be cited as the "Constitution Act, 1934-1978".

8. Section 45 of the principal Act is amended by striking out the passage "by this Act" and inserting in lieu thereof the passage "by or under this Act or any other Act".

9. Section 55 of the principal Act is amended by striking out subsections (3) and (4).

15. Sections 8, 9 and 10 of the principal Act are repealed.

17. Sections 11, 12, 13, 14 and 15 of the principal Act are repealed.
