An Act to amend the Supreme Court Act, 1935-1971; the Industrial Code, 1967-1971; the Local and District Criminal Courts Act, 1926-1971, and the Licensing Act, 1967-1971.

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

AMENDMENT OF THE SUPREME COURT ACT, 1935-1971

- 3. (1) The Supreme Court Act, 1935-1971, as amended by this Short titles. Act, may be cited as the "Supreme Court Act, 1935-1972".
- (2) The Supreme Court Act, 1935-1971, is in this Part referred to as "the principal Act".
 - 4. Section 12 of the principal Act is amended—

Amendment of Salaries of

- (a) by striking out subsection (1) and inserting in lieu thereof the following subsection:-
 - (1) Until the date of commencement of the Statutes Amendment (Judges' Salaries) Act, 1972, the salary of the Chief Justice or acting Chief Justice and the salary of every puisne judge or acting puisne judge shall be at the rates respectively prescribed by this Act as in force immediately prior to that date and on and after that date the salary of the Chief Justice or acting Chief Justice shall be at the rate of twenty-eight thousand two hundred dollars a year and the salary of every puisne judge or acting puisne judge shall be at the rate of twenty-five thousand seven hundred and fifty dollars a year.;

and

(b) by striking out from subsection (2) the passage "Supreme Court Act Amendment Act (No. 2), 1970" and inserting in lieu thereof the passage "Statutes Amendment (Judges' Salaries) Act, 1972".

AMENDMENT OF THE INDUSTRIAL CODE, 1967-1971

5. (1) The Industrial Code, 1967-1971, as amended by this Act Short titles. and by all other amendments (if any) amending the same prior to the commencement of this Act, may be cited as the Industrial Code, 1967-1972.

- (2) The Industrial Code, 1967-1971, is in this Part referred to as "the principal Act".

 Salary of President and Deputy
 President.
- 6. Section 11 of the principal Act is amended by striking out subsection (1) and inserting in lieu thereof the following subsection:—
 - (1) Until the date of commencement of the Statutes Amendment (Judges' Salaries) Act, 1972, the salary of the President and every Deputy President shall be at the rates respectively prescribed by this Act as in force immediately prior to that date and on and after that date the salary of the President shall be at the rate of twenty-two thousand dollars a year and the salary of every Deputy President shall be at the rate of twenty thousand two hundred dollars a year.

- 7. (1) The Local and District Criminal Courts Act, 1926-1971, as amended by this Act and by all other amendments (if any) amending the same prior to the commencement of this Act, may be cited as the Local and District Criminal Courts Act, 1926-1972.
- (2) The Local and District Criminal Courts Act, 1926-1971, is in this Part referred to as "the principal Act".

Amendment of principal Act, s. 5e— Salaries, etc.

- 8. Section 5e of the principal Act is amended by striking out subsection (1) and inserting in lieu thereof the following subsection:—
 - (1) Until the date of commencement of the Statutes Amendment (Judges' Salaries) Act, 1972, the salary of the Senior Judge or Acting Senior Judge appointed and performing any duties under or for the purposes of this Part and the salary of every Judge or Acting Judge appointed and performing any duties under or for the purposes of this Part shall be at the rates respectively prescribed by this Act as in force immediately prior to that date and on and after that date the salary of the Senior Judge or Acting Senior Judge appointed and performing any duties under or for the purposes of this Part shall be at the rate of twenty-two thousand dollars a year and the salary of every Judge or Acting Judge appointed and performing any duties under or for the purposes of this Part shall be at the rate of twenty thousand two hundred dollars a year.

AMENDMENT OF THE LICENSING ACT, 1967-1971

- 9. (1) The Licensing Act, 1967-1971, as amended by this Act Short titles. and by all other amendments (if any) amending the same prior to the commencement of this Act, may be cited as the "Licensing Act, 1967-1972".
- (2) The Licensing Act, 1967-1971, is in this Part referred to as "the principal Act".
- 10. Section 5 of the principal Act is amended by striking out Amendment of principal Act, absection (6) and inserting in lieu thereof the following subsection:— 5.5 subsection (6) and inserting in lieu thereof the following subsection:

Constitution of

(6) Until the commencement of the Statutes Amendment (Judges' Salaries) Act, 1972, the salary of the Chairman and a Deputy Chairman who is appointed as such after the commencement of the Licensing Act Amendment Act, 1971, shall be at the rates respectively prescribed by this Act as in force immediately prior to that date and on and after that date the salary of the Chairman shall be at the rate of twenty thousand two hundred dollars a year and the salary of a Deputy Chairman who is appointed as such after the commencement of the Licensing Act Amendment Act, 1971, shall be at the rate of eighteen thousand four hundred dollars a year.
