An Act to revise the Statute law.

[Assented to 6th October, 1937.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titie.

1. This Act may be cited as the "Statute Law Revision Act, 1937".

Repeals.

2. The Acts named in the first schedule are hereby repealed.

Saving provision.

- 3. (1) Any repeal under section 2 shall not affect—
 - (a) the validity or invalidity of anything done or suffered before the repeal:
 - (b) the validity or invalidity of anything declared to be valid or invalid by any Act so repealed:
 - (c) any right, interest, title, power, or privilege existing or accruing under any Act so repealed:
 - (d) the proof of any past act or thing:
 - (e) the recognition in South Australia under any Act so repealed of any status, right, title or other matter or thing elsewhere acquired in the same circumstances and to the same extent as such recognition would have been granted or given prior to the passing of this Act.
- (2) This section shall not limit the application of any provision of the Acts Interpretation Act, 1915, to any such repeal.

- 4. The Acts mentioned in the second schedule are amended Amendment of in the manner shown in the said schedule.
- 5. Notwithstanding the repeal of the Supreme Court Act, Saving of 1878, paragraph 1. of section 6 of that Act shall, so far as it the Supreme Court Act, relates to the administration of estates of deceased persons, 1878. remain in force until Parliament otherwise provides.
