No. 42 of 1957.

An Act to repeal certain obsolete enactments and to make certain consequential and minor amendments of the Statute Law.

[Assented to 14th November, 1957.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

- Short title.** **1.** This Act may be cited as the "Statute Law Revision Act, 1957".
- Repeals.** **2.** The Acts set out in the first schedule are repealed.
- Amendments.** **3.** The Acts set out in the second schedule are amended in the manner indicated in that schedule.

In the name and on behalf of Her Majesty, I hereby assent to this Bill.

Strike out the definition of "Supreme Court" and insert the following :— "Supreme Court" means the Supreme Court of South Australia.</p> <p>At the end of section 3 add the following subsection :— (2) For the purposes of this Act the Supreme Court sitting in Circuit Sessions shall be deemed to be the Circuit Court for each circuit district in which such circuit sessions are held.</p> <p>Section 9— Strike out "No. 6 of 1868-9" in the third line of subsection (3) and insert "Supreme Court Act, 1935-1955". Strike out the word "sub-districts" wherever occurring in section 9 and insert "subdivisions".</p>

Business Agents Act, 1938-1954	<p>Section 19—</p> <p>Strike out “1925-1936” in the third, ninth, and nineteenth lines of subsection (6) and insert “1955” in each case.</p> <p>Strike out “section 6” in the third and nineteenth lines of subsection (6) and insert “sections 25 and 72”.</p> <p>Strike out “as provided by that section” in the fourth line of subsection (6) and insert “complying with that Act”.</p> <p>Section 22—</p> <p>Strike out “1925-1936” in the third, eighth, and sixteenth lines of subsection (6) and insert “1955” in each case.</p> <p>Strike out “section 7a” in the third and sixteenth lines of subsection (6) and insert “sections 25 and 73”.</p> <p>Strike out “as provided by that section” in the fourth and fifth lines of subsection (6) and insert “complying with that Act”.</p>
