**No. 18 of 1964.****AN ACT to amend the *Agent-General Act* 1911.****[ 5 August 1964. ]**

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1—**(1) This Act may be cited as the *Agent-General Act* 1964. Short title,  
citation, and  
commence-  
ment.

(2) The *Agent-General Act* 1911, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the first day of July 1963.

**2** Section seven of the Principal Act is amended by omitting subsection (1) thereof and substituting therefor the following subsections:— Salary and  
allowances  
of Agent-  
General.

“(1) During the period commencing on the first day of July 1963 and ending on the thirtieth day of June 1964, the Agent-General shall be paid a salary at the rate of three thousand one hundred and thirty-five pounds a year.

“(1A) On and after the first day of July 1964 the Agent-General shall be paid a salary—

- (a) at the rate of three thousand one hundred and eighty-seven pounds a year; or
- (b) such other rate, if any, as may be specified in any order made pursuant to subsection (1B) of this section.

“(1B) If at any time after the first day of July 1964 the basic salary payable to permanent heads of departments of the Public Service pursuant to any award under the *Public Service Tribunal Act* 1958 that is applicable to them is altered (whether by way of increase or decrease) pursuant to that Act, the Governor may, by order, alter the rate of the salary to be paid to the Agent-General to such extent as appears to him to be necessary to conform to the alteration so made to the basic salary payable to those permanent heads and, in any such order, the Governor may specify—

- (a) the altered rate of the salary to be paid to the Agent-General; and
- (b) the date on and after which it is to be paid (which may be a date either before or after the date of the making of the order).”.
