

ACTING APPOINTMENTS (VALIDATION) ACT 1982

AN ACT to validate the acts of persons purporting to have acted in the offices of Registrar-General, Recorder of Titles, and Registrar of Deeds and Deputy Registrar-General, Deputy Recorder of Titles, and Deputy Registrar of Deeds.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Acting Appointments* (*Valida*- short title. *tion*) *Act* 1982.

Commence ment.

2—This Act shall commence on the day on which it receives the royal assent.

Validation of acts, &c., of person purporting to have acted in office of Registrar-General, Recorder of Titles, and Registrar of Deeds.

- **3**—(1) All acts, matters, and things done or omitted to be done in the purported performance and exercise of the duties, obligations, rights, and powers of the Registrar-General, Recorder of Titles, and Registrar of Deeds by the prescribed person during the period commencing on 15th September 1979 and ending on 14th April 1982 shall be as valid and effectual as if the Attorney-General had, pursuant to section 89 of the *Public Service Act* 1973, directed the prescribed person to perform and exercise the duties, obligations, rights, and powers of the Registrar-General, Recorder of Titles, and Registrar of Deeds during that period.
- (2) For the purposes of subsection (1), "prescribed person" means the person who, on 19th February 1979, was directed by the Attorney-General, pursuant to section 89 of the *Public Service Act* 1973, to perform and exercise the duties, obligations, rights, and powers of the Registrar-General, Recorder of Titles, and Registrar of Deeds during any temporary absence or incapacity of the permanent occupant of those offices.

Validation of acts, &c., of person purporting to have acted in office of Deputy Registrar-General, Deputy Recorder of Titles, and Deputy Registrar of Deeds.

- **4**—(1) All acts, matters, and things done or omitted to be done in the purported performance and exercise of the duties, obligations, rights, and powers—
 - (a) of the Deputy Recorder of Titles and Deputy Registrar of Deeds by the prescribed person during the period commencing on 15th September 1979 and ending on 5th July 1982; and
 - (b) of the Deputy Registrar-General by the prescribed person during the period commencing on 6th November 1980 and ending on 5th July 1982,

shall be as valid and effectual as if the Attorney-General had, pursuant to section 89 of the *Public Service Act* 1973, directed the prescribed person to perform and exercise the duties, obligations, rights, and powers of the Deputy Recorder of Titles and Deputy Registrar of Deeds during the period referred to in paragraph (a) and, as the case may be, the Deputy Registrar-General during the period referred to in paragraph (b).

(2) For the purposes of subsection (1), "prescribed person" means the person who, on 28th November 1978, was directed by the Attorney-General, pursuant to section 89 of the *Public Service Act* 1973, to perform and exercise the duties, obligations, rights, and powers of the Deputy Recorder of Titles and Deputy Registrar of Deeds during the absence of the Registrar-General and Recorder of Titles from office due to illness.
