## AN ACT to amend the Architects Act 1929.

# [Royal Assent 30 November 1984]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—This Act may be cited as the Architects Amendment Act 1984. Short title.
- **2**—This Act shall commence on the day on which it receives the commence royal assent.

Principal Act.

**3**—In this Act, the *Architects Act* 1929\* is referred to as the Principal Act.

Amendment of section 13 of Principal Act (Qualifications for registration).

- **4**—Section 13 (1) of the Principal Act is amended by omitting paragraphs (a) and (b) and substituting the following paragraphs:—
  - (a) passed—
    - (i) the examination for the Diploma of Architecture of the Hobart Technical College; or
    - (ii) an examination of a university, college, school, or public institution for the training of architects the passing of which examination is recognized by the Council of the Royal Australian Institute of Architects as conferring an entitlement to apply for admission to corporate membership of that Institute; and
  - (b) completed in the aggregate at least 2 years of practical experience that is approved by the Board and of which at least one year shall be after passing an examination referred to in paragraph (a); and
  - (c) passed such oral and written examinations as may be required by the Board for the purpose of satisfying it that the applicant has acquired a practical knowledge of the architect's profession.

Insertion in Principal Act of new section 23A. **5**—After section 23 of the Principal Act, the following section is inserted:—

Indemnity for members of Board, &c.

23A—A member of the Board, the Registrar, or an officer of the Board shall not incur any personal liability in respect of any act, matter, or thing done, or omitted to be done, in good faith in the execution or purported execution of the provisions of this Act.

Amendment of section 26 of Principal Act (Regulations).

- **6**—Section 26 of the Principal Act is amended by inserting after paragraph (b) the following paragraph:—
  - (ba) regulating the appointment of examiners for the purposes of conducting examinations under section 13 (1) (c);
