By His Excellency SIR WILLIAM THOMAS DENISON, Knight, Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies, with the Advice and Consent of the Legislative Council.

AN ACT for applying certain Sums arising from the Revenue receivable in the Colony of Van Diemen's Land to the Service thereof for the Year One thousand eight hundred and fifty-three. [6th January, 1853.]

W E Her Majesty's most dutiful and loyal Subjects the Members of the Legislative Council of Van Diemen's Land in Council assembled towards making good the Supply which we have cheerfully granted to Her Majesty in this Session of the said Legislative Council have resolved to grant unto Her Majesty's Service the sums hereinafter mentioned and do therefore respectfully request that in pursuance of a certain Act of Parliament passed in the fourteenth year of the reign of Her present Majesty Queen Victoria intituled An Act for the better Government of Her Majesty's Australian Colonies whereby it was among other things enacted that the Governor of the Colony of Van Diemen's Land with the advice and consent of the Legislative Council thereof should have authority to make Laws for the peace welfare and good government of the said Colony and with the deductions and subject to the provisions therein contained by such Laws to appropriate to the Public Service within the said Colony the whole of Her Majesty's Revenue within such Colony arising from Taxes Duties Rates and Imposts levied on Her Majesty's Subjects within such Colony it may be enacted AND BE IT THEREFORE ENACTED by His Excellency Sir William Thomas Denison Knight Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies by and with the advice and consent of the Legislative Council thereof that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service within the said Colony and issued and applied any sum or sums of money not exceeding thirtyone thousand six hundred and nineteen pounds sixteen shillings and ten pence to defray the Salaries Allowances and Contingencies of the Civil and Legislative Departments of the said Colony unprovided for by the Schedule annexed to the said recited Act of Parliament marked C for the year one thousand eight hundred and fifty-three as hereinafter more particularly expressed—that is to say—any sum or 16 Vict. sums of money not exceeding seven hundred and forty-eight pounds five shillings to defray the Salaries Allowances and Contingencies of His Excellency the Lieutenant-Governor's Establishment and any sum or sums of money not exceeding three thousand six hundred and sixty-eight pounds eighteen shillings and three pence to defray the Salaries and Contingencies of the Legislative Council Establishment and any sum or sums of money not exceeding five thousand nine hundred and eighty-seven pounds to defray the Salaries and Contingencies of the Customs' Department and any sum or sums of money not exceeding four thousand eight hundred and seventy-two pounds six shillings and six pence to defray the Salaries and Contingencies of the Post Office Establishment and any sum or sums of money not exceeding nine hundred and five pounds to defray the Salaries and Contingencies of the Department of the Accountant of Stores and any sum or sums of money not exceeding four thousand three hundred and ninety-two pounds seven shillings and six pence to defray the Salaries Allowances and Contingencies of the Department of the Port Officer and any sum or sums of money not exceeding two thousand five hundred and fourteen pounds nine shillings and seven pence to defray the Salaries Allowances and Contingencies of the Department of Public Works and any sum or sums of money not exceeding one thousand seven hundred and ninety-four pounds to defray the Salaries Allowances and Contingencies of the Establishment of the Government Printer and any sum or sums of money not exceeding five hundred and ninety-six pounds to defray the Salaries Allowances and Contingencies of the Department of the Registrar of Births Deaths and Marriages and any sum or sums of money not exceeding ninety pounds to defray the Salaries of the Inspectors of Weights and Measures and any sum or sums of money not exceeding nine hundred and fifty pounds to defray the Salaries and Contingencies of the Education Department and any sum or sums of money not exceeding five thousand and one pounds ten shillings to defray the Salaries and Contingencies of the Miscellaneous Establishment and any sum or sums of money not exceeding one hundred pounds to defray the Salary of the Agent-General in London.

- II. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding three thousand three hundred and fifty pounds to defray the charge for Revenue Services (exclusive of Establishments) of the said Colony for the year one thousand eight hundred and fifty-three.
- III. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding six thousand one hundred and forty-five pounds to defray the charge for Charitable Allowances of the said Colony for the year one thousand eight hundred and fifty-three.
- IV. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum 16 Vict. No. 24.

or sums of money not exceeding six thousand four hundred and twenty-six pounds to defray the charge for Education (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-three.

- V. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five hundred pounds to defray the charge for Government Printer (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-three.
- VI. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one hundred and seventy-five pounds to defray the charge of Police and Gaols (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-three.
- VII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding two hundred and thirty-five pounds to defray the charge of Rent in the said Colony for the year one thousand eight hundred and fifty-three.
- VIII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one thousand seven hundred and forty pounds to defray the charge of Transport in the said Colony for the year one thousand eight hundred and fifty-three.
- IX. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding three thousand eight hundred pounds to defray the charge of Conveyance of Mails of the said Colony for the year one thousand eight hundred and fifty-three.
- X. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding seventeen thousand seven hundred and forty pounds ten shillings to defray the charge of Public Works and Buildings in the said Colony for the year one thousand eight hundred and fifty-three.
- XI. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding four thousand nine hundred and fifty pounds to defray the charge of Roads Streets et cetera in the said Colony for the year one thousand eight hundred and fifty-three.

XII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding four thousand nine hundred and thirty-nine pounds fifteen shillings to defray Miscellaneous Charges of the said Colony for the year one thousand eight hundred and fifty-three.

XIII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one thousand and fifty pounds to defray the charge of Grants in aid of Public Institutions in the said Colony for the year one thousand eight hundred and fifty-three.

XIV. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one thousand pounds to defray the charge of Drawbacks in the said Colony for the year one thousand eight hundred and fifty-three.

XV. AND BE IT ENACTED that the Treasurer of the said Colony shall issue and pay the said several sums to such persons for the purposes hereinbefore mentioned upon such days and in such proportions as the Lieutenant-Governor for the time being by any Warrant or Order in writing to be signed by him shall from time to time order and direct and that the payments so to be made shall be charged upon and payable out of the Revenues of the said Colony.

XVI. AND BE IT ENACTED that the said Treasurer shall in his Accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such Warrant or Order in writing as aforesaid and that the receipt or receipts of the respective persons to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said Accounts for any such sum or sums as shall be therein mentioned and that he shall and do receive credit for the same accordingly.
