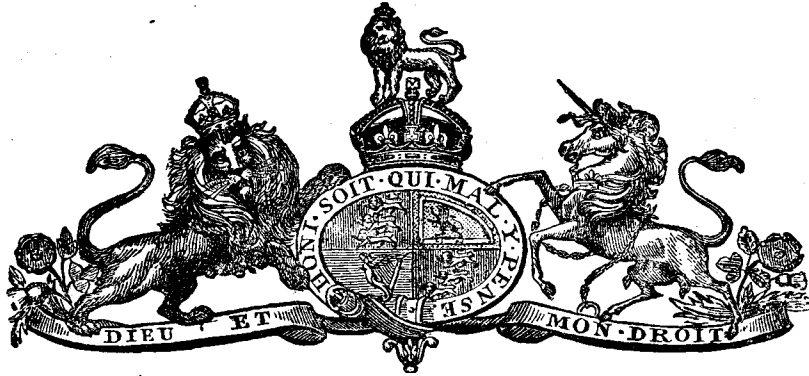

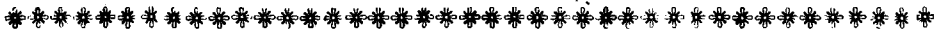

AN ACT for the Relief of the Trustees of the Bank of *Van Diemen's Land*, Limited, and to further amend "An Act to provide for the Winding-up of the Business and Affairs of the Bank of *Van Diemen's Land*, Limited." [30 November, 1906.]

WHEREAS it is expedient to make special provision for the relief of the Trustees of the Bank of *Van Diemen's Land*, Limited, in the manner hereinafter appearing :

PREAMBLE.

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 In this Act, unless the context otherwise determines, the following expressions shall have the meanings hereinafter assigned to them respectively, namely :—

Interpretation.

Bank of Van Diemen's Land Winding-up.

“The said Act” shall mean the Act of the Parliament of *Tasmania*, intituled “An Act to provide for the Winding-up of the Business and Affairs of the Bank of *Van Diemen's Land, Limited* :”

“The said Bank” shall mean the Bank of *Van Diemen's Land, Limited*, mentioned in the said Act :

“The said Trustees” shall mean and include the persons to whom the winding-up of the business and affairs of the said Bank is entrusted by the said Act, and any other Trustee appointed in the place of either of the said Trustees, as provided by the said Act.

Trustees may advertise for claims.

2 It shall be lawful for the said Trustees at any time after the passing of this Act to advertise for claims against the said Bank in manner hereinafter mentioned.

Form of advertisement, and how published.

3 Every advertisement published in pursuance of this Act shall be in the form set out in the Schedule hereto or to the like effect; and such advertisement shall be inserted Twice in the *Hobart Gazette*, and Twice in One newspaper published in *Hobart*, and Twice in One newspaper published in *Launceston*, and Twice in One newspaper circulating on the West Coast of *Tasmania*, and Twice in One newspaper circulating on the North-West Coast of *Tasmania*; the advertisements in any one newspaper to be published at an interval of not less than Ten days.

On expiration of notice Trustees released, except as to claims sent in.

4 At the expiration of Three months from the publication of the last of such advertisements, the said Bank and the said Trustees shall be absolutely released and discharged both at law and in equity from all claims and demands against the said Bank, except at the suit or on behalf of claimants who have sent in their claims on or before the day specified for that purpose in the said advertisement.

On expiration of notice, Trustees may distribute assets.

5 At any time after the expiration of the said period of Three months it shall be lawful for the said Trustees, after satisfying, or retaining sufficient to satisfy, any claim of which notice may be sent in to them, in pursuance of such advertisement as aforesaid, to pay or distribute any assets of the said Bank remaining in their hands *pari passu* among the shareholders of the said Bank who have fully paid all calls in respect of shares held by them in the said Bank.

Definition of term “claim.”

6 For the purposes of this Act, the word “claim” shall signify any debt due by the said Bank or the said Trustees, and for which the said Bank or the said Trustees may be liable or responsible at law or in equity.

In pursuance of the provisions of an Act of the Parliament of Tasmania, intituled "An Act for the Relief of the Trustees of the Bank of Van Diemen's Land, Limited, and to further amend 'An Act to provide for the Winding-up of the Business and Affairs of the Bank of Van Diemen's Land Limited,'" notice is hereby given that all persons having claims on the Bank of Van Diemen's Land, Limited, are required to send in to the Trustees of the said Bank, at their Offices, Auction Chambers, Murray-street, Hobart, the particulars of such claims in writing, on or before the _____ day of _____ now next [or in the year 190], otherwise they will be excluded from any benefit of the assets in the hands of the said Trustees.
