AN ACT to amend the Apple and Pear Industry (Crop Insurance) Act 1982.

[Royal Assent 18 August 1987]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Apple and Pear Industry (Crop Insurance) Amendment Act 1987*. Short title.

2—This Act shall commence on the day on which it receives the Royal assent. Commencement.

3—In this Act, the *Apple and Pear Industry (Crop Insurance) Act 1982** is referred to as the Principal Act. Principal Act.

Repeal of section 13 of Principal Act (Annual statement to be lodged with Director).

4—Section 13 of the Principal Act is repealed.

Amendment of section 15 of Principal Act (False statements, &c.).

5—Section 15 (1) of the Principal Act is amended by omitting “information or”.

Amendment of section 17 of Principal Act (Provision of information to the Board).

6—Section 17 of the Principal Act is amended as follows:—

(a) by omitting “information or”;

(b) by omitting “13 or”.

Amendment of section 20 of Principal Act (Regulations).

7—Section 20 of the Principal Act is amended by omitting subsection (2).

Amendments of Principal Act for purpose of converting monetary penalties into penalty units.

8—The Principal Act is amended as set out in Schedule 1.

Section 7 (5)	Omit "\$1 000" and "\$50", substitute "10 penalty units" and "0.5 penalty unit" respectively.
Section 14 (2)	Omit "\$500", substitute "5 penalty units".
Section 15 (1)	Omit "\$500", substitute "5 penalty units".
Section 16 (2)	Omit "\$250", substitute "2.5 penalty units".
Section 20 (3)	Omit "\$500", substitute "5 penalty units".
