

## MARRIAGE.

### No. 12 of 1950.

AN ACT to amend the *Marriage Act 1942*.  
[30 June, 1950.]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title  
and citation.

**1**—(1) This Act may be cited as the *Marriage Act 1950*.  
(2) The *Marriage Act 1942*\*, as subsequently amended, is in this Act referred to as the Principal Act.

**2** After section three of the Principal Act the following section is inserted in Part I:—

Power of

proclamation.

“3A. The Governor may, if he considers it necessary or desirable so to do, by proclamation, amend the second schedule by adding thereto the name of any religious denomination, or by altering the name of any religious denomination set forth in that schedule, and upon the gazettal of any proclamation under this section the amendment effected thereby shall have effect as if it had been enacted by this Act.”.

**3** The Principal Act is amended by adding at the end of the second schedule thereto the words “The Evangelical Lutheran Church of Australia.”.

## APPROPRIATION (ST. ANN'S REST HOME).

### No. 13 of 1950.

AN ACT to appropriate and apply a sum from the Consolidated Revenue for the purposes of a grant in aid of the establishment and development of a home for aged persons. [30 June, 1950.]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short titl .

**1** This Act may be cited as the *Appropriation (St. Ann's Rest Home) Act 1950*.

**2**—(1) The Treasurer may issue out of the Consolidated Revenue (which, to the necessary extent, is hereby appropriated accordingly) a sum not exceeding £10,000, and apply that sum for the purpose expressed in the schedule. Appropriation and application of £10,000.

(2) The sum appropriated by subsection (1) of this section may be applied in the financial year ending on the thirtieth day of June, 1950, and in any subsequent financial years; and may be applied partly in one financial year and partly in any other financial year or financial years.

Grant in aid of the establishment and development of a home for the aged to be known as St. Ann's Eventide Rest Home (on the basis of one pound for each pound actually expended upon or in connection with the erection of new buildings or the extension or repair of existing buildings proposed to be used for the purposes of the said Home) £10,000
