W HEREAS an Act was passed in the Fifth Year of the Reign of PREAMBLE. **Police Magistrates** to prepare Lists yearly in the month of August after the expirayear.

III. AND BE IT ENACTED that the Police Magistrates or Assistant Police Magistrates as the case may be for Hobart Town New Norfolk Oatlands Swan Port Campbell Town Norfolk Plains Launceston and Richmond respectively shall in the month of October in the tion of the present present year and in the month of August in each succeeding year cause to be prepared and made out in as near as may be the order in which such persons reside from the Police Office in such District a List of every man residing within their respective Districts duly qualified as a Juror according to the provisions of an Act of this Island intituled AnAct for the Extension of Trial by Jury and to regulate the Constitution of Juries with his Christian or Surname or names at full length place of abode and quality calling or business according to the form contained in the Schedule to this Act marked A.

Lists for this year the month of November.

And remain in the hands of the Police Magistrate until the 14th day of the month for inspection.

IV. AND BE IT ENACTED that copies of the said several Lists to be exhibited in so to be prepared during the month of October now next shall be so certified and exhibited upon the Second day of November then next following with a notice thereunder written that all objections to the said List will be heard on the next adjournment day of the Court of General Quarter Sessions to be holden in or for that District which shall happen next after the Fourteenth day of the said month of November.

> V. AND BE IT ENACTED that the original of such last-mentioned Lists shall remain in the hands of the said Police or Assistant Police Magistrate for access by any Inhabitants of the said District from the said Second day of November now next until the Fourteenth day of the said month and no longer.

VI. AND BE IT ENACTED that at such adjournment day as to attend with List last aforesaid at such General Quarter Sessions as aforesaid such Police Magistrate shall attend with such last-mentioned original List and thereupon the Justices assembled (of whom such Police Magistrate shall be and continue to be one) shall proceed to settle the same as by the said Act is directed-PROVIDED ALWAYS that it shall be lawful for every such Court for the purposes last aforesaid to adjourn from time to time if expedient but so nevertheless that every such last-mentioned List shall be finally settled before the end of the said month of November and also that at each Sitting of the Court for the purposes last aforesaid every Police and Assistant Police Magistrate resident within the District for which the Court shall be holden shall be present and assisting thereat.
