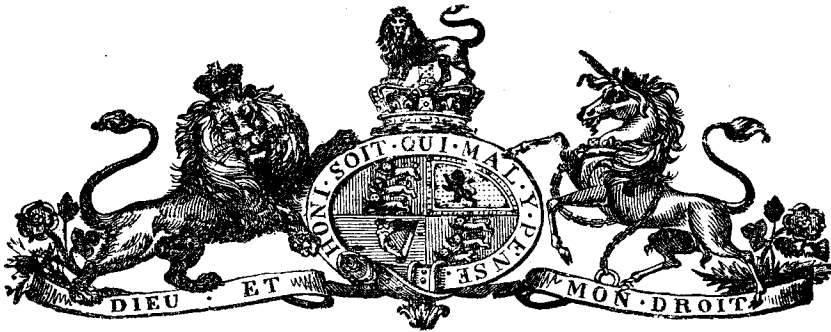

AN ACT to authorise the granting of a A.D. 1901.
Right-of-Way over certain land in the
City of *Hobart*. [13 December, 1901.]

WHEREAS, in pursuance of the provisions of the Act of the PREAMBLE.
Parliament of *Tasmania* intituled "An Act to make provision for the
purchase of Land required in connection with the erection of new Post
and Telegraph Offices, *Hobart*," the Minister has purchased certain
land fronting on *Elizabeth-street*, in the City of *Hobart* (hereinafter
referred to as "the said land"), and such land has been surrendered
to the Crown :

And whereas, pursuant to the provisions of the said Act, the
Minister has agreed with *Davies Brothers, Limited*, to exchange a
portion of the said land for other land adjoining the same and
belonging to such company :

And whereas part of the consideration for such exchange was that a
right-of-way should be granted over part of the land so purchased as
aforesaid :

And whereas it is desirable that legislative authority should be given
for the granting of such right-of-way :

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Governor may
grant right-of-
way.

1—(1.) It shall be lawful for the Governor to grant to *Davies Brothers, Limited*, and their assigns, a Right-of-way over, along, and upon a strip of land Twelve feet in width being now Crown land, and extending from the said *Elizabeth-street* in a north-easterly direction, thence in a north-westerly direction, thence again in a north-easterly direction, and thence again in a south-easterly direction to the said land owned by *Davies Brothers, Limited*, and from time to time to revoke such Right-of-way.

(2.) If at any time any Right-of-way granted pursuant to the provisions of this Act shall be revoked the Governor shall, at the time of such revocation, grant to the said *Davies Brothers, Limited*, and their assigns, in lieu thereof, a Right-of-way over, along, and upon another strip of land Twelve feet in width forming part of the land so purchased as aforesaid, and extending from the said *Elizabeth-street* to the said land owned by the said *Davies Brothers, Limited*.

2 Every such Right-of-way shall be a right for the said *Davies Brothers, Limited*, and their assigns, and for the tenants and occupiers for the time being of the said land of the said *Davies Brothers, Limited*, and their assigns, and for their or any of their agents, servants, and workmen, and all and every other persons and person, by their or any of their permission, or for their or any of their benefit, from time to time and at all times by night and by day, and for all purposes, to go, return, pass and repass, with or without horses, cattle, carts, and other carriages, over, along, and upon the strip of land over which any such Right-of-way may be granted as aforesaid.

And there shall be reserved in the grant of such Right-of-Way the right to erect any structure over the Right-of-Way at a height of not less than Fifteen feet from the surface thereof.
