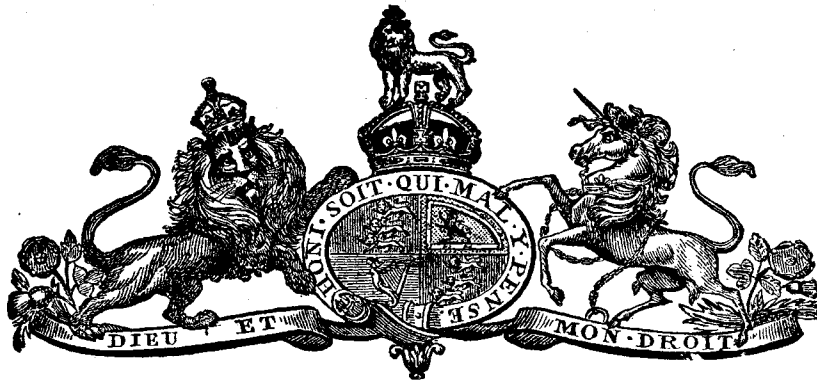

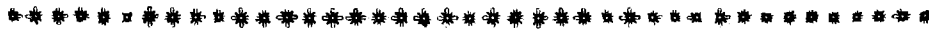

AN ACT to authorise the Loan of Three hundred Pounds to the Warden, Councillors, and Electors of the Municipality of Port Cygnet in accordance with the provisions of "The Local Public Works Loans Act, 1890," and to further amend "The Port Cygnet Municipality Loan Act, 1912," and for other purposes. [23 December, 1916.]

WHEREAS under and by virtue of "The Port Cygnet Municipality Loan Act, 1912" (hereinafter called "The Principal Act"), the Council of the Municipality of Port Cygnet was authorised to borrow on behalf of the Warden, councillors, and electors of the Municipality of Port Cygnet, the sum of One thousand seven hundred Pounds, for the purpose of defraying the cost and expenses of, and incidental to erecting a public hall at Lovett, in Tasmania :

And whereas under and by virtue of "The Port Cygnet Municipality Loan Act, 1913" (hereinafter called "The Amending Act"), the Principal Act was thereby amended by authorising the said Council to borrow the further sum of Three hundred Pounds, for the purpose of completing the erection of the said hall :

And whereas the said Council is desirous of borrowing a further sum of Three hundred Pounds for the purpose of defraying the cost and expenses of and incidental to the erection of a billiard room, library, and bioscope room at Lovett aforesaid :

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

Amendment of Principal Act as to amount borrowed, substituting £2300 for £2000.

**1** The Principal Act, as amended by the amending Act, is hereby further amended as from the commencement of the Principal Act, by omitting therefrom the words "Two thousand Pounds," wherever occurring, and substituting for those words the words "Two thousand three hundred Pounds," and the Principal Act shall be read and construed as if it had from its commencement authorised a loan of Two thousand three hundred Pounds.

Amendment of Section 3 of Principal Act.

**2** There shall be inserted after the word "hall" in line Five of Section Three of the Principal Act, the words "and a billiard room, library, and bioscope room at Lovett aforesaid."

How further loan to be expended.

**3** It shall be lawful for the Council of the said Municipality to expend the said sum of Three hundred Pounds for the purposes mentioned in Section Two hereof.

Previous poll to be sufficient.

**4** The poll taken on the Twenty-fifth day of April, One thousand nine hundred and twelve, is declared to be sufficient for the purposes of the Principal Act as further amended by this Act.
