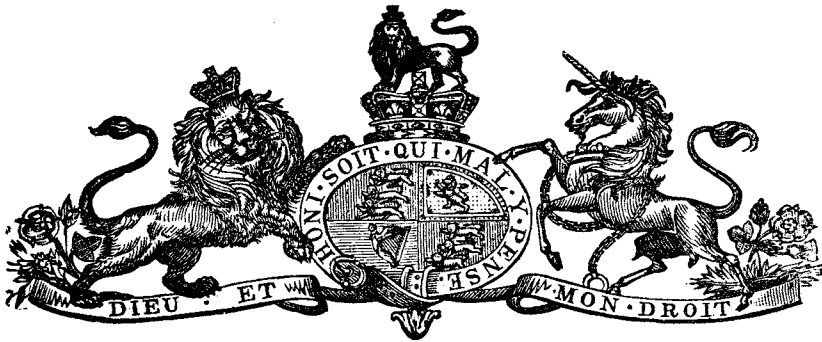

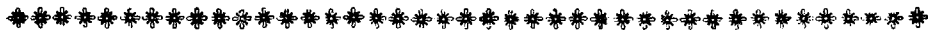

AN ACT to authorise the raising of the Sum of Seven hundred and fifty thousand Pounds by the Issue of *Tasmanian* Stock. [3 September, 1894.]

A.D. 1894.

WHEREAS the Governor is authorised by the Acts of the Parliament 55 *Victoria*, No. 82, and 56 *Victoria*, No. 56, to issue *Tasmanian* Stock to the amount of £2,100,000 for the purposes therein mentioned: And whereas the Governor has issued *Tasmanian* Stock under the provisions of the said Acts to the amount of £1,600,000, leaving a balance of £500,000 of *Tasmanian* Stock still available for issue: And whereas certain of the moneys to be derived from the sale of the said £500,000 of *Tasmanian* Stock will not now be required for the purposes mentioned in the said Acts, and it is desirable to apply such moneys for and towards the purposes mentioned in the Schedule (1.) hereto: And whereas it is expedient to raise a further sum of £250,000 by the issue of *Tasmanian* Stock: Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

PREAMBLE.

1 The power granted to the Governor to raise money by the issue of *Tasmanian* Stock under the authority of the Acts mentioned in the Schedule (2.) to the extent of £500,000 is hereby revoked, but such revocation shall not in any way affect any *Tasmanian* Stock issued

Power granted under Acts mentioned in Schedule (2.) revoked.

*Tasmanian Stock, £750,000.*

- A.D. 1894. — under the provisions of the said Acts at the day when this Act comes into operation.
- Stock may be issued under this Act. **2** The Governor may, from time to time, issue *Tasmanian* Stock charged and secured on "The Consolidated Revenue Fund" to an amount not exceeding Seven hundred and fifty thousand Pounds for the purposes mentioned in the Schedule.
- 52 Vict. No. 55. Such Stock shall be issued in the manner provided by "The Inscribed Stock Act, 1889," and shall be subject to all the provisions of that Act.
- Redemption of Stock. Rate of interest. **3** All Stock issued under the provisions of this Act shall be redeemable not later than the year One thousand nine hundred and forty, and shall bear interest at a rate not exceeding Four Pounds per centum per annum.
- Payment of interest on such Stock. **4** The interest on all Stock issued under the authority of this Act shall be payable half-yearly, on the First day of *January* and the First day of *July* in every year; and all such interest shall be charged upon and be issued out of "The Consolidated Revenue Fund," and the principal moneys secured by such Stock shall be a charge upon such Fund until repaid.
