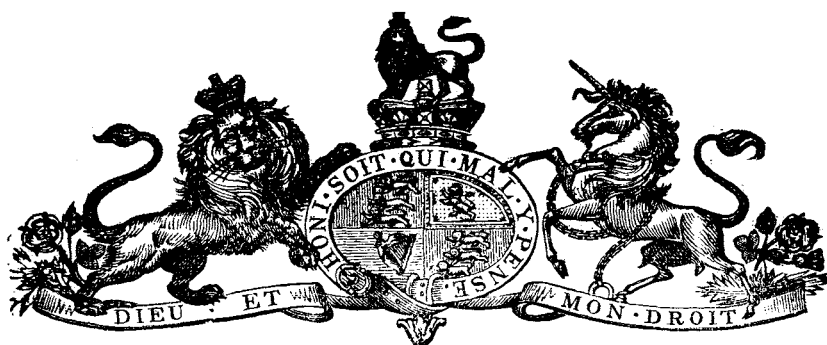

AN ACT to create a Public Recreation A.D. 1889.
Ground at *Cornelian Bay*, and to appoint
Trustees thereof. [5 *December*, 1889.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 So much of the Esplanade upon the River *Derwent*, situate between *Cornelian Bay* and *New Town Bay* upon the said River, as is described and set forth in the Schedule to this Act shall, subject to the provisions of this Act, be a Public Recreation Ground under and for the purposes of "The Public Recreation Grounds Act, 1888;" and the Trustees of the *Hobart* Public Cemetery for the time being, and the Chairmen for the time being of the Trustees of the *Loinah* Road District, the *Augusta* Road District, and the *South Glenorchy* Road District shall be, and they are hereby declared to be, the Trustees of the Public Recreation Ground constituted by this Act for the purposes of the said Act; and the provisions of the said Act relating to the appointment, election, and retirement of Trustees shall not apply to the Trustees of the Recreation Ground constituted by this Act, but all the other provisions of the said Act shall apply to the said Trustees.

2 The said Trustees may enclose, fence, and plant the said Public Recreation Ground in such manner as they see fit, with the approval of the Governor in Council. Powers of Trustees.

3—(1.) Nothing herein contained, nor any power vested in the Trustees of the said Recreation Ground, shall be held or construed to deprive any of Her Majesty's subjects of full power to pass and repass over, across, or along the land vested in the said Trustees, on foot or with any horses, carriages, or vehicles, at all reasonable times for the purposes of health and enjoyment, subject to any Regulations made by the said Trustees for the use and occupation of the said Recreation Ground.

(2.) In case any portion of the land hereby vested in the Trustees is at any time deemed by the Governor in Council to be necessary to be resumed for any public purpose, it shall be lawful for the Governor or any person authorised by the Governor in that behalf to enter thereupon without suit, and thereupon such land shall revert to the Crown as and for the same estate and interest as the Crown now has in the said land, subject to such rights of way, if any, and to any other rights to which the said land may be subject at the time of passing this Act.

SCHEDULE.

TOWN OF NEW TOWN.

All that piece of land, One hundred and fifty feet wide, forming the Esplanade, commencing at the road leading from New Town Bay to Cornelian Bay on New Town Bay, and lying between the Cornelian Bay Cemetery and New Town Bay, the River Derwent, and Cornelian Bay, and extending to other portion of the before-mentioned road on Cornelian Bay.
