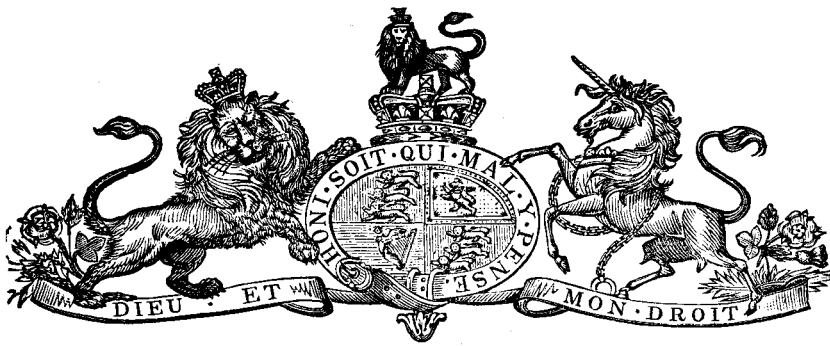

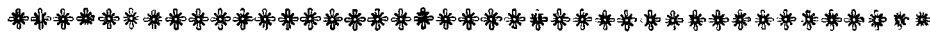

AN ACT to empower the Municipal Council of the Rural Municipality of *Fingal* to sell a certain piece of Land and the Buildings thereon, and to appropriate the Proceeds thereof. [21 *December*, 1892.] A.D. 1892.

WHEREAS the piece of land described and set forth in the Schedule hereto was, with other land, granted to the Warden, Councillors, and Electors of the Municipality of *Fingal* : PREAMBLE.

And whereas the said land and the buildings thereon being no longer required for Municipal purposes, it is expedient to empower the said Municipal Council of the said Municipality to sell the said land and the buildings thereon, and to apply the proceeds of the sale of such land in the manner hereinafter appearing :

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1—(1.) The Municipal Council of the Rural Municipality of *Fingal* is hereby empowered to sell and convey the land set forth and described in the Schedule hereto, and the Buildings thereon, notwithstanding anything to the contrary contained in any Grant Deed granting such land. Municipal Council may sell land.

(2.) The said Municipal Council shall apply the moneys received from the sale of the said land for and towards the erection of a Police Application of proceeds of sale.

Office, Constables' Quarters, Cells, and Stables at the Town of *St. Mary's*, in the said Municipality, and for and towards the completion and repair of the house in the Town of *Fingal* occupied by the present Council Clerk of the said Municipal Council.

SCHEDULE.

TOWN OF FINGAL.*Section B. 2A. 2R. 12P.*

(Being portion of 8a. 2r. 29p. granted to the Warden, Councillors, and Electors of the Municipality of Fingal.)

Bounded on the north east by four chains and forty-seven links south-easterly along Short-street commencing at the angle of that street with the Esplanade on the South Esk River, on the south east by one chain and fifteen links south-westerly along the Fingal and St. Mary's Railway Reserve, again on the south east by six chains and fifty-four links south-westerly also along that Reserve, on the south west by two chains and forty-six links north-westerly along other portion of the above-mentioned land granted to the Warden, Councillors, and Electors of the Municipality of Fingal to the Esplanade aforesaid, on the north west by two chains and thirty-five links north-easterly along that Esplanade, and thence again on the north west by five chains and ninety-six links north-easterly also along that Esplanade to the point of commencement.
