

### AN ACT to provide for the Inspection of A D. 1886. the Carcases of Pigs within *Hobart* and [8 December, 1886.] Launceston.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1 The unsalted carcass or any portion of the unsalted carcass of any Carcases of pigs pig which shall be brought for sale within the City of Hobart or the brought into Town of Launceston, or within One mile of the boundaries of such City or Town, shall be inspected by an Inspector of Stock or other person sale to be appointed by the Municipal Council of the said City or Town respectively inspected. to inspect carcases of cattle and sheep, as provided in the Act of the Parliament of *Tasmaniu* of the 44th *Victoriæ*, No. 24, initialed "An 44 Vict. No. 24. Act to facilitate the Sale of Meat within *Hobart Town* and *Launceston*;" and every person who in any manner whatsoever acts in contravention of this Section shall for every such offence be liable to a penalty not exceeding Twenty Pounds.

2 All unsalted carcases and portions of carcases of pigs brought Carcases to be into the said City or Town for sale shall be conveyed to the place appointed by the Municipal Council thereof for inspecting the carcases of cattle and sheep as provided in the said Act; and there shall be paid to the Inspector or person appointed as hereinbefore mentioned such fees as shall from time to time be fixed by the Municipal Councils

of the City of *Hobart* and Town of *Launceston* respectively in respect of the inspection of the carcass or part of the carcass of any animal intended for sale as human food, which said several sums of money shall be paid to such Inspector or person forthwith; and if the same is not paid forthwith on demand such carcass or part of the carcass shall be forfeited to the use of such Inspector or person.

Carcass not to be removed or sold until inspected.

**3** No carcass or portion of any carcass shall be removed from the place appointed for inspecting the same, or sold, until the same has been inspected as hereinbefore required; and if any person acts in contravention of this provision he shall be liable to a penalty not exceeding Five Pounds.

Recovery of penalties.

4 All offences against this Act may be heard and determined, and all penalties may be recovered in a summary way, by and before any Two Justices of the Peace, in the mode prescribed by *The Magistrates* Summary Procedure Act.

Appeal from penalties. 19 Vict. No. 10. **5** Any person who thinks himself aggrieved by any penalty imposed under the authority of this Act may appeal against the same in the mode prescribed by *The Appeals Regulation Act*.
