

AN ACT to provide for the Selection and A.D. 1895. Purchase by certain Persons of certain [24 October, 1895.] Crown Lands.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :--

1. Notwithstanding anything to the contrary contained in Section Certain persons Fifty-one of "The Crown Lands Act, 1890," a Grant may be issued to the persons named in the Schedule (1.) hereto for the lands set oppo-site their respective names upon such persons paying all instalments due thereon and effecting substantial improvements other than buildings residing on land. upon such land to the value of not less than One Pound per acre for every acre of such land set opposite their names respectively; and in default of such persons effecting such improvements upon such land within a period of eight years from the date of the contract of sale and purchase thereof, such land shall be liable to be forfeited to the Crown.

2 Notwithstanding anything to the contrary contained in any Act, Certain persons the Commissioner may, with the consent of the Governor in Council, whose land has permit the persons named in the Schedule (2.) to be restored as purchasers of the several areas set opposite to their names, subject to the provisions of "The Crown Lands Act, 1890," and thereupon such persons shall be liable to pay all instalments due upon such lands at

the date of forfeiture, and all instalments thereafter due thereon, together with the amount of fine and charge for cost of advertising as provided in Section Seventy-one of the said Act.

3 The Governor may, in the name and on behalf of Her Majesty, convey and alienate in fee simple, or for any less estate or interest, to *Alfred Beck* and *James Beck* One hundred and thirty-nine acres Three roods and Five perches or thereabouts of Crown land, upon the said *Alfred Beck* and *James Beck* surrendering to the Crown the One hundred and thirty-nine acres Three roods and Five perches of land purchased by them in the Parish of *Loatta*, County of *Westmorland*, and paying the cost and expenses of and incidental to such surrender and the survey and grant deed of such first-mentioned land.

4 Notwithstanding anything to the contrary contained in "The Crown Lands Act, 1890," the Commissioner may allow *Thomas James Watson* to select Crown Land, subject to the provisions of the said Act, in lieu of Three hundred and twenty acres of land selected by the said *Thomas James Watson* in the Parish of *Nietta*, County of *Devon*, and forfeited to the Crown for non-payment of the instalments; and it shall be lawful for the Commissioner to apply the sum of Two hundred and two Pounds Thirteen Shillings and Fourpence, paid by the said *Thomas James Watson* as instalments upon the last-mentioned land, in and towards the payment of the purchase money upon any land selected by the said *Thomas James Watson* under the provisions of this Section.

5 Notwithstanding anything to the contrary contained in *The Immigration Act*, the Commissioner may accept a Land Order valued at Thirty Pounds, issued to the Reverend Father *Martial Mary* under the provisions of *The Immigration Act*, as part payment of the purchase money of Forty-nine acres and Two perches of Crown land in the Parish of *Goshen*, County of *Cornwall*, which land was originally selected by *John Pritchard* and transferred by him to the said Reverend Father *Martial Mary*.
