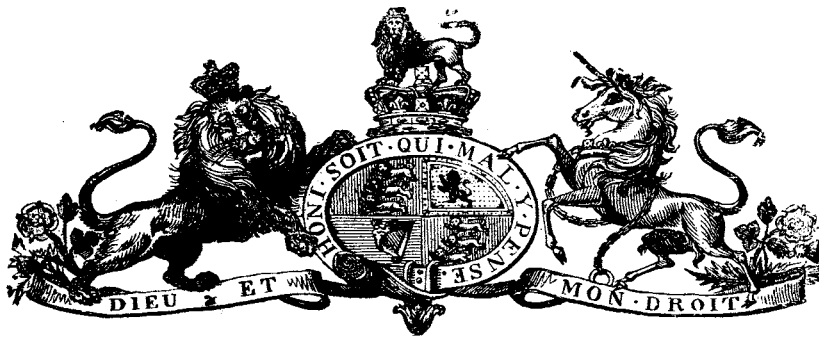

AN ACT to re-appropriate certain Moneys A.D. 1895.  
for and towards the Construction of Roads,  
and for other purposes. [24 October, 1895.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

**1** The Minister may expend any sum of money not exceeding One thousand Pounds upon the construction, maintenance, and improvement of Roads generally, provided that the sum of One Pound is locally raised and expended on any Road for every One Pound expended by the Minister on such Road. Minister may expend money on Roads.

Provided that no money shall be expended under this Act in any year by the Minister in any Road District in which a Shilling Road Rate has not been levied and collected during such year, but such Road Rate shall be in addition to and shall not form any part of the moneys raised for the purposes of this Act.

**2** The cost of such Roads shall be defrayed out of the unexpended balances of the moneys provided by Parliament for the several Works mentioned in the Schedule, and it shall be lawful for the Treasurer to appropriate the same accordingly. Appropriation.

**3** All the provisions contained in "The Public Works Construction Act, 1880," and "The Branch Roads Construction Act, 1881," shall extend and apply to such Roads as fully in all respects as if the said provisions had been incorporated in this Act.

**4** The words "and Bridge over Jackey's Creek" in item 89 of the Schedule (1.) to "The Branch Roads Construction Act, 1889," are hereby expunged.

**5** The words "Metalling Bell-street, *Risdon*," in line two of the Second page of Schedule (2.) of "An Act to provide for the Execution of certain Public Works" are hereby repealed, and the words "Road from Domain Gate to Football Ground" are hereby inserted in lieu thereof.
