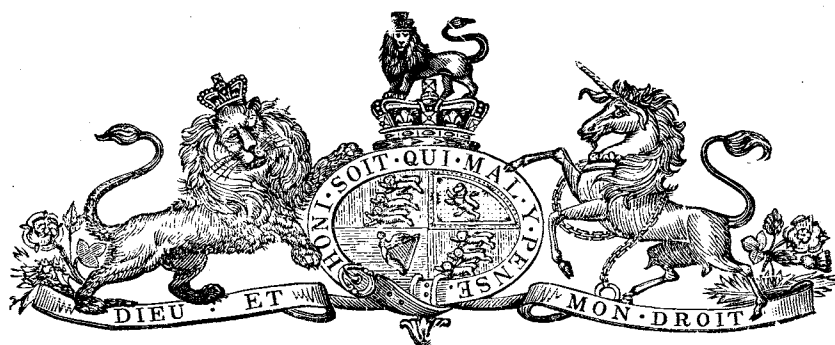

AN ACT to remove doubts as to the operation of "The Electoral Act, 1896," and to validate certain Electoral Rolls and Polling Lists. [11 July, 1899.]

A.D. 1899.

WHEREAS "The Electoral Act, 1896," was declared to remain and continue in full force and operation until the Thirty-first day of December, One thousand eight hundred and ninety-eight :

PREAMBLE.

And whereas during the last Session of Parliament a Bill was passed by both Houses of Parliament, *inter alia*, to continue the said Act for a further period, but the Royal Assent to such Bill was not proclaimed in *Tasmania* until the Third day of February, One thousand eight hundred and ninety-nine :

And whereas doubts have arisen as to whether "The Electoral Act, 1896," has been in force as from the Thirty-first day of December, One thousand eight hundred and ninety-eight :

And whereas it is desirable that such doubts should be removed, and that certain Electoral Rolls and Polling Lists should be ratified by Parliament :

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 "The Electoral Act, 1896," shall for all purposes be deemed to be and to have been in force as from the Thirty-first day of December, One thousand eight hundred and ninety-eight ; and all acts, matters,

and things done or purporting to have been done under or in compliance with the provisions of that Act since such last-mentioned date are hereby declared to be valid and effectual.

2 The Electoral Roll and Polling List for the Electoral Districts of *Derwent* and *Gordon*, as prepared by the Returning Officer for the Electoral District of *Derwent*, and respectively signed by him on the Twentieth and Eighteenth days of *May*, One thousand eight hundred and ninety-nine, are hereby declared to be the Electoral Roll and Polling List respectively for the Districts of *Derwent* and *Gordon*; and the Electors whose names are on such Rolls shall be entitled to vote at any Election of a Member to represent either of such Districts, as the case may be, in the Legislative Council between the date of the passing of this Act and the Eleventh day of *April*, One thousand nine hundred.

3 The Electoral Roll and Polling List for the Electoral Districts of *Zeehan* and *Lyell*, as prepared by the Returning Officer for the Electoral District of *Zeehan*, and signed by him on the Thirteenth day of *May*, One thousand eight hundred and ninety-nine, are hereby declared to be the Electoral Roll and Polling List respectively for the Districts of *Zeehan* and *Lyell*; and the Electors whose names are on such Rolls shall be entitled to vote at any Election of a Member to represent either of such Districts, as the case may be, in the House of Assembly between the date of the passing of this Act and the Eleventh day of *April*, One thousand nine hundred.
