

AN ACT to revest in Her Majesty the A.D. 1899.

Queen a certain piece of Land in the City of Hobart, and to vest in the Mayor,

Aldermen, and Citizens of the City of Hobart a certain other piece of Land in the said City.

[22 December, 1899.]

WHEREAS the land described in Schedule (1.) has for many PREAMBLE. years been used by the public as forming part of a Public Street, although the same has never been reserved as a Street:

And whereas the said piece of land is now required for the purposes of erecting thereon, in conjunction with other land, a new Custom House:

And whereas the land described in the Schedule (2.) hereto has heretofore formed part of a Public Street known as Davey street:

And whereas it is now required by the Crown for the purposes of erecting thereon, in conjunction with other land, a new Custom House, and for other purposes:

And whereas, in order to maintain the width of the said Street, it is desirable that the land described in the Schedule (3) hereto should be transferred from the control of the Marine Board of *Hobart* to the Corporation of the City of *Hobart*, and form part of *Davey*-street:

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Land Vesting, Hobart.

A.D. 1899.

Certain land vested in Her Majesty. 1 The pieces of land described in Schedule (1.) and (2.) hereto are hereby vested in Her Majesty, her heirs, and successors, and the said pieces of land shall henceforth cease to be, or form part of any public and common highway or thoroughfare, and may lawfully be enclosed by walls or otherwise, and appropriated to such purposes as Her Majesty, or the Governor acting on Her Majesty's behalf, shall deem expedient.

Certain land vested in the Corporation of *Hobart*.

2 The piece of land described in the Schedule (3.) hereto is hereby vested in, and shall be held, enjoyed, possessed, and used by the Mayor, Aldermen, and Citizens of the City of *Hobart* for the purposes of a roadway, and the Marine Board of *Hobart* shall cease to have or to exercise any right of possession, or care or control thereof.

SCHEDULE.

CITY OF HOBART.

0a. 0r. 24p.

Bounded on the north west by one hundred and six feet and three inches southwesterly along the Bonding Warehouse, commencing at the east angle thereof, again on the north west by one hundred and twelve feet and two inches south-westerly, on the south east by two hundred and twenty-five feet and eight inches north-easterly, thence by a curved line for a distance of ninety-five feet, and thence on the west by eighty feet and six inches southerly to the point of commencement.

CITY OF HOBART.

OA. OR. 27P.

Bounded on the south east by three hundred and twenty-one feet or thereabouts south-westerly, commencing at a point on Dunn-street distant ninety-three feet or thereabouts north-westerly from the north angle of Constitution Dock, on the south west by eight feet or thereabouts north-westerly, on the north west by fifty-five feet five inches north-easterly along a reserve, again on the north west by two hundred and twenty-five feet and eight inches north-easterly along the land hereinbefore described in Schedule (1.), thence by a curved line of ninety-five feet or thereabouts to the east angle of land granted to the Officers of Her Majesty's Ordnance, and thence by a curved line of ninety feet or thereabouts south-easterly to the point of commencement.

CITY OF HOBART.

0a. 1r. 4p.

Bounded on the north east by thirty-seven feet north-westerly along Dunn-street, commencing at a point distant sixteen feet or thereabouts north-westerly from the north angle of the Constitution Dock, on the north west by three hundred and twenty-one feet or thereabouts south-westerly along Davey-street, on the south west by thirty-seven feet south-easterly along Argyle-street, and thence on the south east by three hundred and twenty-one feet or thereabouts north-easterly to the point of commencement.
