## AN ACT to regulate the Conveyance and Postage of [31st August, 1853.] Letters.

W HEREAS a certain Act of Council or Ordinance of this Island PREAMBLE. was passed in the Ninth year of the reign of His Majesty King George the Fourth intituled An Act to provide for the Temporary Conveyance 9 Geo. 4, No. 6. and Postage of Letters-AND WHEREAS a certain other Act of Council or Ordinance of this Island was passed in the Fourth year of the reign of His late Majesty King William the Fourth intituled An 4 W. 4, No. 18. Act to amend and consolidate the Laws providing for the Conveyance and Postage of Letters-AND WHEREAS a certain other Act of Council or Ordinance of this Island was passed in the Fifth year of the reign of Her present Majesty Queen Victoria intituled An Act to 5 Vict., No. 15. amend an Act passed in the Fourth Year of the Reign of His late Majesty King William the Fourth intituled An Act to amend and consolidate the Laws providing for the Conveyance and Postage of Letters—AND WHEREAS it is expedient that the said recited Acts of Council or Ordinances of this Island should be repealed and that the several enactments thereof should with certain alterations amendments and modifications be consolidated into one Act in the manuer hereinafter provided-BE IT THEREFORE ENACTED by His Excellency Sir William Thomas Denison Knight Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies with the advice of the Legislative Council of the said Island that on Repeals above from and after the first day of November now next ensuing this Act recited Acts. shall come into operation and the said several recited Acts of Council or Ordinances of this Island shall be and the same are hereby repealed excepting always as to all or any offences committed or matters or things done before that day all which offences matters and things shall be dealt with as if this present Act had not been passed.

Lieutenant-Governor may abolish and establish Post Offices.

And make rules and regulations.

II. AND BE IT ENACTED that it shall be lawful for the Lieutenant-Governor of this Island and he is hereby empowered with the advice of the Executive Council thereof to abolish such existing Post Offices in this Colony and to establish such new Post Offices therein as to such Lieutenant-Governor with such advice as aforesaid shall from time to time seem desirable or necessary and also to make such rules and regulations for the establishing governance and managing of Post Offices within this Colony—for the receiving despatching conveying carrying and delivering of Letters and Packets for the making custody and sale of Stamps—for the receipt and payment of moneys in connection with the said Post Offices and the conduct of all Postmasters and other Officers of and belonging to the Postal Department as shall from time to time be deemed expedient and it shall also be lawful for such Lieutenant-Governor with such advice as aforesaid from time to time to amend alter vary revoke or annul any such rules or regulations as aforesaid and to make other rules and regulations in the stead of such rules or regulations as shall be so revoked or annulled.

Lieutenant-Governor to appoint Postmaster-General &c.

III. AND BE IT ENACTED that it shall be lawful for the Lieutenant-Governor of this Island and he is hereby empowered from time to time to appoint a Postmaster-General an Inspector or Inspectors of Stamps and such and so many Postmasters and other Officers Clerks and Servants for the conducting and managing of the Post Offices within this Colony and to cause to be paid to them respectively such reasonable Salaries and Allowances as to such Lieutenant-Governor shall seem meet and it shall also be lawful for the Lieutenant-Governor from time to time to remove any such Postmaster-General Inspector of Stamps Postmaster Officer Clerk or Servant and to appoint some other person in the place and stead of such Postmaster-General Inspector of Stamps Postmaster Officer Clerk or Servant so removed as occasion may require.

Oath to be taken by Postmasters &c.

IV. AND BE IT ENACTED that the Postmaster-General and every other Postmaster Clerk Letter Carrier or other person appointed under this Act and employed in the receiving despatching conveying carrying sorting or delivering of Letters or Packets shall previously to the exercise by him of the duties of his office take and subscribe an oath for the due performance and execution of such duties such oath to be taken before any one of Her Majesty's Justices of the Peace for this Island and its Dependencies who is hereby authorised and required to administer the same in the words following that is to say-

"1 A.B. [Postmaster-General as the case may be] do swear that I will not "willingly or knowingly open detain return or delay or cause or suffer "to be opened detained returned or delayed any Letter or Packet which "shall come into my hands power or custody by reason of my employ-"ment relating to the Post Office except in cases authorised by this Act "or by any rule or regulation made under or by virtue thereof."

V. AND BE IT ENACTED that all Letters and Packets transpayable by weight. mitted or received by Post save as hereinafter excepted shall on from 17 VICT. No. 6.

and after the day when this Act shall come into operation be charged by weight only according to the following scale that is to say—for any weight not exceeding half an ounce avoirdupois one rate of Postage and for each additional half ounce or fraction of half an ounce beyond half an ounce one additional rate of Postage-PROVIDED ALWAYS Certain Letters that it shall be lawful for the Postmaster-General or any Postmaster and Packets may under this Act to refuse to transmit by Post any Letter or Packet exceeding sixteen ounces in weight or of inconvenient form or dimensions or containing or reasonably suspected to contain any article or thing likely to be injurious to the other contents of the mail-bags.

VI. AND BE IT ENACTED that save as hereinafter excepted the Rates of Postage. following shall be the rates of Postage payable according to the scale aforesaid upon Letters and Packets transmitted or received by Post that is to say—upon all Letters and Packets received at any Post Office for Town Letters. delivery at such Post Office or at any place within the limits of the City or Town in which such Post Office is situate the sum of One Penny-and upon all Letters and Packets received at any Post Office Country Letters. for delivery beyond the limits of the City or Town in which such Post Office is situate or for transmission by ship to any place beyond the Ship Letters. limits of this Colony the sum of Four Pence.

VII. AND BE IT ENACTED that the sum of Sixpence only for Postage on any weight not exceeding four ounces and the additional sum of Six- Packets containpence for each additional four ounces or portion thereof shall be paid as ingcertainarticles. the rate of Postage on Packets of the following descriptions that is to say—Packets containing notes orders specie or pass-books sent by or to any Bank or Banker-Packets containing patterns or samples of merchandize bona fide sent as such—Packets open at each end containing prices current and catalogues of merchandize-Packets containing writs and proceedings of any Court of Justice or deeds or conveyances or wills or any memorial of any deed conveyance or will or of any judgment bond fide intended for registration according to law or affidavits or letters of attorney—and Packets open at each end containing printed Votes and Proceedings of Parliament or of any Colonial Legislature or pamphlets magazines reviews or other periodical publications (newspapers excepted)—PROVIDED that there shall No writing to be not be in or upon any such Packet any letter or epistolary contained in such communication or intelligence and that are the article shall represent the contained in such packets and form communication or intelligence and that on the outside thereof of endorsement in addition to the name and address of the person to whom the thereon. same is to be delivered the sender thereof shall subscribe with his name and address a statement of the contents thereof (as the case may be) in such form as the following—that is to say—" Banker's Parcel" or "Patterns of Merchandize" or other proper and appropriate description within and in accordance with the terms in this section contained-AND PROVIDED ALSO that it shall be lawful for the Power to refuse Postmaster-General or any Postmaster under this Act to refuse to certain Packets. transmit by Post any such Packet exceeding sixteen ounces in weight or of inconvenient form or dimensions or containing or reasonably suspected to contain any article or thing likely to be injurious to the other contents of the mail-bags.

VIII. AND BE IT ENACTED that the sum of Sixpence only for any weight not exceeding four ounces and the additional sum of Sixpence for each additional four ounces or portion thereof shall be paid as the rate of postage on any Packet containing a single printed book of what nature soever or containing placards or prospectuses – PROVIDED that upon every such Packet as last aforesaid which shall be received at any Post Office for transmission by ship to any place beyond the limits of this Colony there shall be paid the sum of Sixpence as Sea-postage thereon in addition to each sum of Sixpence payable as inland Postage upon such Packet—PROVIDED ALSO that there shall not be in or upon any such Packet as in this section mentioned any letter or epistolary communication or intelligence and that on the outside thereof in addition to the name and address of the person to whom the same is to be delivered the sender thereof shall in manner similar to that in the last preceding section mentioned subscribe with his name and address a statement of the contents thereof—PROVIDED ALSO that it shall be lawful for the Postmaster-General or any Postmaster under this Act to refuse to transmit by post any such Packet as last aforesaid which shall be of inconvenient form or dimensions or which shall exceed three pounds avoirdupois in weight—PROVIDED ALSO that no such Packet containing any book shall be transmitted by post to any place in this Colony to which the mail shall be conveyed on horseback or on foot unless the Lieutenant-Governor shall so authorise and direct.

IX. AND BE IT ENACTED that the sum of Sixpence only for any weight not exceeding four ounces and the additional sum of Sixpence for each additional four ounces or portion thereof shall be paid as the rate of Postage on any Packet containing maps charts or music -PROVIDED that there shall not be in or upon any such Packet as last aforesaid any letter or epistolary communication or intelligence and that on the outside thereof in addition to the name and address of the person to whom the same is to be delivered the sender thereof shall in manner similar to that in the last two preceding sections mentioned subscribe with his name and address a statement of the contents thereof— PROVIDED ALSO that it shall be lawful for the Postmaster-General or any Postmaster under this Act to refuse to transmit by Post any such Packet as last aforesaid which shall exceed three pounds avoirdupois in weight or which shall be folded in size and dimensions exceeding fifteen inches in length or six inches in breadth—PROVIDED ALSO that no such Packet as last aforesaid shall be transmitted by Post to any place in this Colony to which the mail shall be conveyed on horseback or on foot unless the Lieutenant-Governor of this Island shall so authorise and direct.

X. AND BE IT ENACTED that if any person shall wilfully or knowingly send to or put into or cause to be sent to or to be put into any Post Office any Packet having a cover marked and subscribed as in the three lastly preceding sections mentioned which shall contain any other article than the articles thereby described to be contained therein or which shall contain any letter or epistolary communication or intelligence every such person shall for any such offence forfeit and pay a penalty or sum not exceeding Ten Pounds.

XI. AND BE IT ENACTED that all newspapers enclosed either Newspapers to be separately or with others in an envelope open at both ends shall be free of Postage. received conveyed and delivered by Post free of all Postage whatsoever -PROVIDED that no such newspaper or envelope shall contain any printing writing or thing whatsoever therein or thereon other than the contents of such newspaper as printed by the publisher or publishers thereof excepting only the direction on the outside thereof and if any person shall wilfully or knowingly send to or put into or cause to be sent to or put into any Post Office any newspaper or newspapers or envelope which shall contain any printing writing or thing whatsoever therein or thereon other than the contents of such newspaper as printed by the publisher or publishers thereof every such person shall for any such offence forfeit and pay a penalty or sum not exceeding Ten Pounds.

XII. AND in order to remove doubt as to what printed papers shall Definition of term be deemed to be newspapers within the meaning of this Act—BE IT Newspaper. ENACTED that any pamphlet or paper containing any public news intelligence or occurrences or any remarks or observations thereon or upon any matter in Church or State or containing only or principally advertisements printed for sale and published periodically or in parts or numbers at intervals not exceeding Thirty-two days between the publication of any two such pamphlets papers parts or numbers shall if such pamphlet paper part or number do not exceed two sheets (exclusive of any cover or blank leaf or any other leaf upon which any advertisement or other notice shall be printed) or be published for sale at a sum not exceeding Sixpence be deemed and taken to be and shall be a newspaper within the true intent and meaning of this Act.

XIII. AND BE IT ENACTED that nothing in this Act contained Certain Letters shall be taken to authorise or shall authorise any charge for Postage and Packets exupon any Letter or Packet addressed to the Lieutenant-Governor of Postage. this Colony or franked by him or by his Private Secretary or upon any Letter or Packet bond fide on the Public Service only on which there shall be indorsed the words "On Public Service only" and which shall be franked by any Member of the Legislative Council of this Island or upon any Packet enclosing maps or plans transmitted by or addressed to the Surveyor-General or Deputy-Surveyor-General of this Island or upon any Packet containing returns of births baptisms marriages or deaths transmitted in compliance with the provisions of any law then in force by any minister of religion or other person whose duty it may be to transmit such returns to any officer whose duty it may be to receive the same or upon any Packet containing depositions in any case of felony or misdemeanor-PROVIDED that there shall not be in or upon No writing to be any such Packet enclosing or containing maps plans returns or depositions contained in cerany letter or epistolary communication or intelligence and that on the tain of such Packoutside thereof the sender thereof shall subscribe with his name and endorsement address a statement of the contents thereof (as the case may be) in such thereon, form as the following-that is to say-"Maps" "Plans" "Returns of Births" or other proper and appropriate description within and in accordance with the terms in this Section contained.

Postage on Letters of soldiers and sailors.

XIV. AND BE IT ENACTED that no Letter from or to any non-commissioned officer private soldier seaman or marine employed in the Army Navy or Marines shall be chargeable with a higher rate of Postage than the sum of One Penny—PROVIDED that every such Letter shall not exceed one half-ounce in weight and that upon the outside of any such Letter from any such non-commissioned officer private soldier seaman or marine there shall be written in the hand-writing of and signed by the Commanding Officer for the time being of the corps regiment detachment or ship to which such non-commissioned officer private soldier seaman or marine belongs the name of such Officer and of such corps regiment detachment or ship—PRO-VIDED ALSO that any such Letter to any such non-commissioned officer private soldier seaman or marine shall specify upon the same the corps regiment detachment or ship to which such non-commissioned officer private soldier seaman or marine belongs.

Franking.

XV. AND BE IT ENACTED that it shall be lawful for the Lieutenant-Governor and he is hereby empowered from time to time as to him shall appear expedient to exempt from Postage all Letters and Packets which shall be bona fide on the public service only and be addressed to or franked by such Public Officers of the Government as such Lieutenant-Governor shall from time to time for that purpose specify and name—PROVIDED ALWAYS that on every such Letter or Packet there shall be endorsed the words "On Public Service only" and that on any such Letter or Packet franked by any such Public Officer as aforesaid such frank shall be subscribed to such words "On Public Service only" and that on any such Letter or Packet addressed to any such Public Officer the sender thereof shall endorse the words "On Public Service only" and shall subscribe his signature to such words and if any such Public Officer as aforesaid or any person being the sender of any such Letter or Packet as last aforesaid shall send to or put into or cause to be sent to or put into any Post Office any Letter or Packet endorsed franked or subscribed as aforesaid which shall not be on public service only every such Public Officer or person shall for any such offence forfeit and pay a penalty or sum not exceeding Ten Pounds.

Certain Petitions and Addresses exempted from Postage.

Form of endorsement.

XVI. AND BE IT ENACTED that all Petitions and Addresses to Her Majesty the Queen or to the Lieutenant-Governor of this Island and any Petition for presentation to the Executive or Legislative Council of this Island addressed to any Member of such Executive or Legislative Council shall be received conveyed and delivered free of all Postage whatsoever—PROVIDED that every such Petition or Address shall be enclosed in a cover open at both ends and that the sender thereof shall endorse on such cover that the contents thereof is such Petition or Address as the case may be and shall subscribe his signature thereto and if any person shall wilfully or knowingly send to or put into or cause to be sent to or put into any Post Office any Letter or Packet enclosed endorsed and subscribed as last aforesaid which shall not contain solely and only the document described upon the cover thereof to be contained therein every such person shall for any such offence forfeit and pay a penalty or sum not exceeding Ten Pounds.

XVII. AND BE IT ENACTED that the Postmaster-General or Postage Stamps Inspector or Inspectors of Stamps under this Act shall with the approval to be made and of the Lieutenant-Governor of this Island from time to time cause stamps to be made and sold indicating such amounts of Postage as may in that behalf be directed by such Lieutenant-Governor.

XVIII. AND BE IT ENACTED that if any person shall fraudulently Punishment for forge or imitate or assist in forging or imitating any stamp made under forging or uttering the authority of this Act or shall offer utter dispose of or put off any Stamps. forgery or imitation of any such stamp with intent to defraud such person so offending shall be guilty of felony and on conviction thereof shall be subject and liable to imprisonment with or without hard labour or if a male to be worked on the roads or other public works of this Colony for such term not exceeding seven years as the Court before whom such person shall be tried shall think fit to award.

XIX. AND BE IT ENACTED that on from and after the said The Postage on all First day of November the Postage upon all Letters and Packets Letters and Packwhich shall be posted at any Post Office within this Colony shall ets save as exbe prepaid and that (save as by this Act is excepted) such prepay- paid by Stamps. ment shall be made by the affixing thereon of stamps issued by the Postmaster-General or the Inspector or Inspectors of Stamps and that (save as by this Act is excepted) no Letter or Packet shall be received or if received shall be transmitted by any Postmaster unless the stamp or stamps required by this Act shall be affixed thereon—PROVIDED Postmasters to ALWAYS that it shall be incumbent on every Postmaster to procure keep a supply of and keep on hand such supply of stamps for sale without premium to any person desirous of purchasing the same as the Lieutenant-Governor shall from time to time in that behalf authorise and direct and that whenever it shall happen that any Postmaster shall not have any stamps on hand for sale as aforesaid of the required value then and in such case prepayment on any Letters or Packets received by such Postmaster may be made in money and such prepayment by monies shall be acknowledged by such Postmaster upon the face of such Letters or Packets so prepaid.

XX. AND BE IT ENACTED that the Stamps upon all Letters How Postage and Packets shall be affixed to or impressed upon the outside thereof Stamps to be and above the address written thereon and that no Postmaster shall be affixed. bound to take any notice of or pass any Stamp or Stamps which shall be affixed to or impressed elsewhere upon any Letter or Packet than as herein directed.

XXI. AND BE IT ENACTED that all Letters or Packets bearing Letters and Packany Stamp or Stamps which shall have been previously used and having ets bearing any mark thereon which shall have been made at any Post Office by way of obliteration or defacement for the purpose of indicating that such to be treated as Stamp or Stamps had been once used shall be treated as Unpaid Letters unpaid. or Packets as the case may be and if any person shall wilfully Punishment for knowingly and fraudulently remove or attempt to remove from any removing obliter-Stamp which shall have been previously used any such mark which ating marks from 17 VICT. No. 6.

shall have been so made thereon by way of obliteration or defacement for such purpose as aforesaid or shall wilfully knowingly and fraudulently put off or use or attempt to put off or use any such obliterated or defaced Stamp as aforesaid with intent in any such case to defraud every such person shall be deemed guilty of a misdemeanor and shall be liable to be imprisoned with or without hard labour or if a male to be worked on the roads or other public works of this Colony for such term not exceeding Three Years as the Court before whom such person shall be tried shall think fit to award.

Registration of Letters.

XXII. AND BE IT ENACTED that any person who shall send any Letter or Packet by post shall be entitled to have the same registered at the Post Office at which the same shall be posted upon payment of the sum of One Shilling as a fee for such registration and any such Registered Letter or Packet shall be received at such Post Office and be delivered at the place to which the same shall be addressed at or between such hours in the day and subject to such rules and regulations as the Postmaster-General shall from time to time in that behalf direct make and appoint—PROVIDED that no such registration shall render any Postmaster liable for the loss of any such Letter or Packet so registered as aforesaid or of the contents thereof—PROVIDED ALSO that every such registration fee shall be prepaid by Stamps affixed to or impressed upon every such Letter or Packet so registered as aforesaid.

A List of the unclaimed undelivered and refused Letters and Pack-Office to be exhibited for three months.

XXIII. AND BE IT ENACTED that within Sixteen days after the receipt of any Mail the Postmaster by whom or into whose Post Office the same shall have been received shall cause a list of all the ets at each Post then remaining unclaimed undelivered or refused Letters and Packets received in and by such Mail to be made out in writing and affixed to in or on some conspicuous part of such Post Office so that the same may be legible from the outside thereof and such list or other like list or lists containing a true account or statement of all Letters and Packets from time to time remaining unclaimed undelivered or refused shall be so kept affixed clearly written and legible as aforesaid for the space of not less than Three calendar months next following the first receipt of such Letters and Packets respectively and at the expiration of the said period of Three calendar months or as soon as possible afterwards such Letters or Packets as shall still remain unclaimed undelivered or refused shall be transmitted by such Postmaster to the General Post Office at Hobart Town to be there dealt with as by this Act is in that behalf provided.

Such Letters and Packets then to be sent to the General Post Office Hobart Town.

Postmasterlists of all unclaimed undelivered and refused Letters and Packets received at General Post Office Hobart Town.

XXIV. AND BE IT ENACTED that the Postmaster-General General to publish shall once in every month or oftener if he shall so think fit cause a list to be published in the Hobart Town Gazette of all unclaimed undelivered and refused Letters and Packets (Newspapers excepted) which shall have been received at the General Post Office at Hobart Town since the last preceding publication of the like kind and upon the expiration of Three calendar months from the date of any such publication such Letters and Packets mentioned therein as shall not have been claimed and delivered shall be opened in manner hereinafter provided.

XXV. AND BE IT ENACTED that it shall be lawful for the Letters and Pack-Postmaster-General and for every Postmaster under this Act to detain etsposted contrary any Letter or Packet which shall be posted contrary to the provisions detained. thereof or of any rule or regulation made under or by virtue thereof and every such Postmaster shall forward all Letters and Packets so detained for any such cause as aforesaid to the General Post Office at Hobart Town and all such detained Letters and Packets shall be forthwith opened at the said General Post Office at Hobart Town aforesaid in the manner hereinafter provided for the purpose of ascertaining the writer or sender thereof.

XXVI. AND BE IT ENACTED that all Letters and Packets How and by which under the provisions of this Act shall be required to be opened whom unclaimed shall be opened by the Postmaster-General in the presence of an fused and detained Officer of the General Post Office at Hobart Town aforesaid to be Letters and specially nominated for that purpose by the Postmaster-General or by Packets to be an Officer of the said General Post Office for that purpose nominated opened. by the Postmaster-General in the presence of some other Officer of such General Post Office for that purpose also nominated by the Postmaster-General and any such Officer shall before he shall enter upon his duties in this respect make oath before any Justice of the Peace for this Island and its Dependencies (which oath such Justice is hereby authorised and empowered administer) that he will not intentionally read or examine the contents or any part of the contents of any Letter or Packet which he shall open except in so far as may be necessary for the purpose of ascertaining the name and address of the writer or sender thereof and that he will not divulge to any person whatsoever except to the Postmaster-General for the time being any of the contents of any such Letter or Packet which shall have come to his knowledge in the course of opening and examining such Letter or Packet for the purpose aforesaid and if any such Officer shall act in contravention of this provision of this Act or of the obligation of the oath so to be made by him as aforesaid he shall be guilty of an offence against this Act and shall for such offence forfeit and pay a penalty or sum not exceeding Fifty Pounds to be recovered in a summary way before any two Justices of the Peace for this Island and its Dependencies upon the complaint in that behalf of the Postmaster-General or by information of debt at the suit of Her Majesty the Queen in the Supreme Court of this Island.

XXVII. AND BE IT ENACTED that the Postmaster-General shall Return of such cause any unclaimed undelivered refused or detained Letter or Packet Letters and which shall have been so opened as aforesaid to be returned to the writer or Packets to writers sender thereof upon the name and address of such writer or sender being or senders. ascertained by such reading and examination of such Letter or Packet as aforesaid and if the original Postage by law payable upon any such Letter or Packet the writer or sender whereof shall be so ascertained shall not have been paid such writer or sender thereof shall thereupon be liable to pay the same and if any such writer or sender shall refuse to receive any such Letter or Packet as last aforesaid or to pay the 17 Vict. original Postage by law payable upon any such Letter or Packet upon demand thereof made by the Postmaster-General or on his behalf it shall be lawful for the Postmaster-General forthwith to destroy the same or to enforce the payment of such postage as aforesaid thereon.

Simplifying proceedings for recovery of Postage.

XXVIII. AND BE IT ENACTED that in any suit or other proceeding for the recovery of any Postage payable under or by virtue of this Act the person from whom any Letter or Packet in respect of which such Postage shall be sought to be recovered shall purport to have come shall be deemed the sender thereof and the onus shall lie upon such person of proving that such Letter or Packet did not come from or was not sent by him.

Postage-mark to be evidence of amount of Postage payable.

XXIX. AND BE IT ENACTED that in any proceeding whatsoever for the recovery of any Postage the Post Office mark upon the Letter or Packet in respect of which such postage shall be sought to be recovered shall be evidence of the liability of such Letter or Packet to the postage marked thereon.

Letters and Packets not to be sent or delivered otherwise than provided.

XXX. AND BE IT ENACTED that saving and excepting such Letters and Packets as shall by virtue of the provisions of this Act be opened for the purpose of ascertaining the writers or senders thereof no directed except as Letter or Packet whatsoever shall after the same shall have been once put into any Post Office under any circumstances be returned to the writer or sender thereof or be sent or delivered otherwise than according to the direction thereof without the express consent of the person to whom the same shall be directed or an express warrant or authority in writing under the hand of the Lieutenant-Governor of this Island.

Postmaster-General may sell or destroy certain articles contained in Packets remaining un-claimed &c. for a certain period.

XXXI. AND BE IT ENACTED that it shall be lawful for the Postmaster-General and he is hereby empowered to cause to be destroyed or sold all pamphlets magazines reviews and other periodical publications and all printed votes and proceedings of Parliament or of any Colonial Legislature and all prices current catalogues of merchandize and patterns or samples of merchandize which shall continue to be unclaimed undelivered or refused for the period of three calendar months from the date of the publication of the hereinbefore required list in which the Packet containing any such pamphlet magazine review periodical publication votes and proceedings prices current catalogues patterns or samples shall have been so notified and published as aforesaid and it shall also be lawful for the Postmaster-General to cause to be destroyed all newspapers which shall continue to be unclaimed for the period of three calendar months from the receipt thereof at any Post Office under this Act and also to cause to be destroyed all unclaimed undelivered refused and detained Letters and Packets the writers or senders whereof it shall be impossible to ascertain and which shall in the case of Letters or Packets by this Act required to be published have continued to be so unclaimed or undelivered for the period of one year from the date of the publication of any list in which the same shall have been so notified and published as aforesaid—And the proceeds of all

AND BE IT ENACTED that it shall be lawful for the Postmaster-General under such instructions as shall from time to time in that behalf be issued by the Lieutenant-Governor from time to time to enter into any contract or contracts in writing in his own name on behalf of Her Majesty the Queen for or in respect of the carriage or conveyance of mails by sea and therein to fix the amount to be paid for such carriage or conveyance either by periodical payments of agreed sums or by payments at any agreed rate for each and every Letter and Packet and also therein to impose such terms and conditions as to such Postmaster-General shall seem fit with regard to the vessels to be employed—the times of starting—and otherwise for securing the due regular and efficient performance of such service and it shall be lawful for such Postmaster-General to sue and be sued in his own name upon any such contract and if any party to such contract shall during the continuance thereof refuse or neglect to perform the same or shall in any manner be guilty of any breach thereof or omit to comply with any stipulation or provision contained therein every such party shall be guilty of an offence against this Act and shall upon conviction thereof forfeit and pay a penalty or sum not exceeding Fifty Pounds irrespective of any penalty recoverable for such default by virtue of any bond or instrument into which any such party or his sureties may have entered for the due performance of such contract.

XLI. AND BE IT ENACTED that in all vessels by which mails shall be conveyed between any ports harbours or places within this Colony or between any port harbour or place within this Colony and any port harbour or place in any other of Her Majesty's Australasian Colonies there shall be provided a suitable locker or other secure place in which such mails and all letters and packets forwarded by Post shall be locked up and carried apart from all other articles and things on board of such vessels and if such locker or other secure place shall not be so provided or if any such mail or any such letter or packet shall be conveyed or carried in any such vessel during the whole or any part of the voyage between any such ports harbours or places or port harbour or place as aforesaid otherwise than as aforesaid the master of or person commanding such vessel shall be guilty of an offence against this Act and shall on conviction thereof forfeit and pay a penalty or sum not exceeding Twenty-five Pounds.

AND WHEREAS Letters and Packets forwarded by dulently retaining Post are sometimes by mistake delivered to the wrong person and Letters and Packets forwarded by Post and bags containing posted Letters and Packets are sometimes lost in the course of conveyance or delivery thereof and are detained by the finders thereof in expectation of gain or reward-for remedy thereof-BE IT ENACTED that any person who shall fraudulently retain or wilfully secrete keep or detain or who shall after demand made by an Officer of the Post Office neglect or refuse to deliver up any Letter or Packet forwarded by Post which shall have been wrongfully delivered and which shall be in the possession power or custody of such person or any Letter or Packet forwarded by Post or any bag box or package containing posted Letters or Packets which shall have been lost in the course of conveyance or delivery thereof and which shall come to or be in the possession power or custody of such person whether such Letter Packet bag box or package shall have been found by such person so retaining secreting keeping detaining or neglecting or refusing to deliver up the same or by any other person whatsoever shall be guilty of an offence against this Act and shall on conviction thereof forfeit and pay a penalty or sum not exceeding Fifty Pounds.

Penalty for unlawfully opening &c. Letters and Packets.

XLVIII. AND BE IT ENACTED that if any person shall except as by this Act is provided knowingly open detain or delay or cause or suffer to be opened detained or delayed any Letter or Packet after the same shall have been delivered into any Post Office or into the house of any person employed in the receiving carrying or delivering of Letters or Packets under this Act without the express authority of the person to whom such Letter or Packet shall be directed every such person shall for any such offence forfeit and pay a penalty or sum not exceeding Fifty Pounds.

Taking Letters or Packets from Post Office &c. felony.

XLIX. AND BE IT ENACTED that if any person shall frau. dulently take from the possession of any Postmaster or person employed in the receipt conveyance or delivery of Letters or Packets forwarded by Post or from or out of any Post Office or place appointed for the receipt or delivery of Letters or Packets forwarded by Post or 17 Vict.
