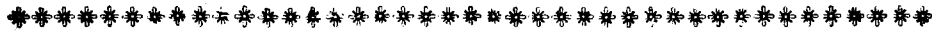

AN ACT to regulate the Payment of certain A.D. 1892.
Moneys in aid of the Road Rates in
certain Road Districts and Towns.
[21 December, 1892.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 There shall be payable by the Treasurer in the year One thousand eight hundred and ninety-three, out of the Consolidated Revenue Fund of the Colony for that year, any sum or sums of money, not exceeding in the whole Nine thousand five hundred Pounds, for and towards the construction and repair of Roads, Streets, and Bridges, other than Main Roads, and such money shall be payable—

- i. To the Trustees of those Road Districts in which a Road Rate shall have been made and levied in accordance with the provisions of "The Roads Act, 1884," in the year ending on the Twenty-eighth day of *February*, One thousand eight hundred and ninety-three; and 48 Vict. No. 28.
- ii. To the Boards of those Towns in which a Road Rate shall have been made and levied in accordance with the provisions of "The Town Boards Act, 1891," in the year ending on the Thirty-first day of *December*, One thousand eight hundred and ninety-two: in the following proportions, that is to say:—

- (a) To the Trustees of every Road District and the Board of every Town in which a Road Rate of

not less than Sixpence and less than Ninepence in the Pound on the annual value of the property in such District or Town has been levied, a sum equal to one-half part of the money collected by such rate :

(b) To the Trustees of every Road District and the Board of every Town in which a Road Rate of not less than Ninepence and less than One Shilling in the Pound on the annual value of the property in such District or Town has been levied, a sum equal to two-thirds part of the money collected by such Rate :

(c) To the Trustees of every Road District and the Board of every Town in which a Road Rate of One Shilling in the Pound on the annual value of the property in such District or Town has been levied, a sum equal to the amount of money collected by such rate :

Provided, that in the event of the said sum of Nine thousand five hundred Pounds being insufficient to pay to each such Road Trust and Board the amount which they would respectively be entitled to receive under the provisions of this Section, then the amount to be paid to each of such Road Trusts and Boards shall be reduced in the proportion which the sum of Nine thousand five hundred Pounds bears to the total amount to which the Road Trusts and Boards would be entitled to receive under the provisions of this Section.

Provided, that in any case where a Town Board has levied a Road Rate exceeding Ninepence in the Pound, and has also levied for Town Board and Drainage purposes a Rate exceeding Threepence in the Pound, such Town Board shall be entitled to rank with those Road Trusts and Town Boards receiving the highest subsidy, and shall receive a subsidy proportionate to the amount of Road Rate actually levied for the year ending Thirty-first day of *December*, One thousand eight hundred and ninety-two.

Maximum and minimum payments.

2 In no case shall there be paid to the Trustees of any Road District or to the Board of any Town a sum greater than the proceeds of a Rate of One Shilling in the Pound upon the annual value of the property in such Road District or Town, nor shall any sum be paid to the Trustees of any Road District or the Board of any Town in which a Road Rate or Road Rates of less than Sixpence in the Pound on the annual value of the property in such Road District or Town has been levied and collected in the years respectively aforesaid.

No payments to be made unless Accounts, &c. forwarded to Auditor-General before certain time.

3—(1.) No portion of the said sum of Nine thousand five hundred Pounds shall be paid to the Trustees of any such Road District unless the Statement and Account for the preceding year of such Trustees, as required by "The Roads Act, 1884," are forwarded to the Auditor-General before the Thirty-first day of *March*, One thousand eight hundred and ninety-three.

(2.) No portion of the said sum of Nine thousand five hundred Pounds shall be paid to the Board of any Town unless the Statement and Accounts of such Board for that year as required by "The Town Boards Act, 1891," are forwarded to the Auditor-General before the last day of *February*, One thousand eight hundred and ninety-three.
