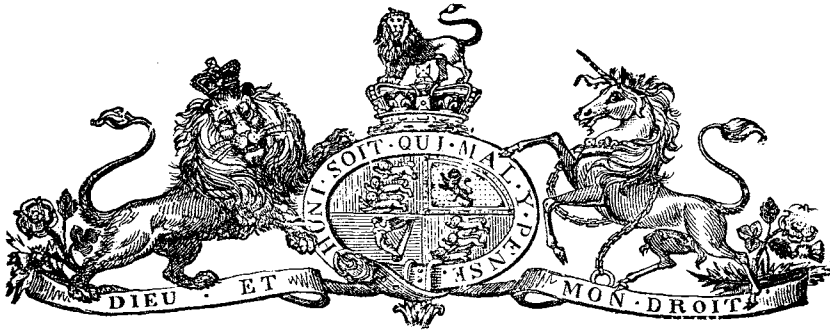

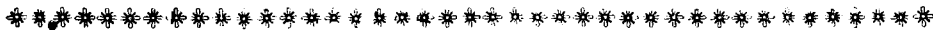

AN ACT to vest in the University of *Tasmania* A.D. 1892.
the Property known as "The High School
of *Hobart*." [21 *December*, 1892.]

WHEREAS by a Deed of Association dated the Twenty-third day of *February*, One thousand eight hundred and forty-eight, a Company or Association was formed at *Hobart Town* for the purpose of establishing and carrying on at *Hobart Town* aforesaid an Institution having for its immediate object the instruction of youth in the higher branches of learning as taught in superior English, Classical, and Mathematical Schools; but having for its ultimate object the extension of its organization and its aims concurrently with the growing wants of the community of *Van Diemen's Land*, and more particularly to obtain for it the privileges of a chartered Corporation to confer on *Australian* youth the inestimable advantages of a European University: PREAMBLE.
And whereas by Letters Patent dated the Twenty-eighth day of *April*, One thousand eight hundred and forty-eight, the piece of land situate in the *Queen's Domain*, *Hobart*, and described in the Schedule hereto, was granted by Her Majesty the Queen to *Thomas Daniel Chapman*, *Henry Hopkins*, *Robert Officer*, *Alexander M'Naughtan*, *William Robertson*, and *William Rout*, their heirs and assigns for ever:
And whereas by Deed Poll dated the Eighteenth day of *October*, One thousand eight hundred and forty-eight, under the hands and seals of the said grantees, it was declared that the grantees should stand seised of the said piece of land upon trust for the said Company

or Institution called "The High School of *Hobart Town*," and to be for ever used and appropriated exclusively for the purposes of such Institution: Provided that if the said Company or Institution should by effluxion of time or from any cause whatever be dissolved or cease to exist then the grantees should stand seised of the said land upon trust to be for ever used and appropriated exclusively for the purposes for which the said Company or Institution had been formed and established:

And whereas the said Company or Association shortly afterwards expended large sums of money in erecting buildings on the said land and in establishing such school; and such school was for many years carried on under the name of "The High School of *Hobart*," but has been now for some time closed:

And whereas the said Company or Association has long since dissolved by effluxion of time, and the grantees of the said land have been some time dead:

And whereas, in order to give full effect to the purposes for which the said land was granted by Her Majesty, and particularly for the promotion and encouragement of sound learning and education in *Tasmania*, it is deemed expedient that the said land and the buildings thereon should be forthwith vested in the University of *Tasmania*, and that the Council of the University should be empowered to apply out of the funds of the University a sum of money in the repair and improvement of the buildings on the said land:

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Land described in Schedule vested in University of *Tasmania*.

1 The piece or parcel of land described in the Schedule hereto is hereby vested in the University of *Tasmania*, to be held and used for the purposes of the said University: Provided, that the said land or any part thereof shall not at any time be sold, mortgaged, or otherwise alienated; and in the event of the said land and premises not being used for University purposes the same shall revert to the Crown for educational purposes.

Power to expend money on repairs, &c.

2 It shall be lawful for the Council of the University to apply out of the funds of the University a sum not exceeding Three hundred Pounds in the repair and improvement of the buildings on the said piece of land.

SCHEDULE.

All those four acres two roods and twenty-five perches of land situate and being in the suburbs of the City of Hobart, in *Tasmania*, and bounded on the south east by six chains north-easterly along the Queen's Domain, being a line in continuation of the north-west side of Bathurst-street commencing at the fence on the north-east side of Park-street, on the north east by seven chains ninety-four links and one half link north-westerly also along the Queen's Domain, on the north west by six chains south-westerly also along the Queen's Domain to Park-street aforesaid, and thence on the south west by a straight south-easterly line of seven chains and ninety-eight links along that street to the point of commencement.
