AN ACT to provide for the application of certain moneys granted to this State by the Commonwealth for the purposes of Forestry and of certain other Moneys to be borrowed and raised by the Treasurer for the like

WHEREAS by section nine of the Loan Appropriation (Unemployment Relief) Act 1934-35 of the Commonwealth it is provided that an amount not exceeding twenty-five thousand pounds may be granted to this State by way of financial assistance for the purposes of forestry, subject to the conditions set forth in that Act:

## Aid to Forestry (Federal Grant).

And whereas the Federal Treasurer has determined certain conditions under which the moneys to be so granted as aforesaid shall be used by this State, and has approved of a scheme of forestry operations to be carried out with the aid of such moneys and of a further sum of five thousand pounds to be provided by this State:

And whereas, among the conditions so determined by the Federal Treasurer as aforesaid, was a condition that the forestry scheme should be carried out under the general direction of two trustees, one of whom should be appointed by the Commonweath and the other by the State:

And whereas it is desirable to make provision for the carrying out of the forestry scheme and for the application of the moneys to be so granted and provided as aforesaid:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

## Short title and commencement.

1 This Act may be cited as the Aid to Forestry (Federal Grant) Act 1935, and shall be deemed to have come into force on the fifth day of April, one thousand nine hundred and thirty-five.

#### Interpretation.

#### 2 In this Act—

- "The Commonwealth Act" means the Loan Appropriation (Unemployment Relief') Act 1934-1935:
- "The Federal Treasurer" means the Treasurer of the Commonwealth:
- "The forestry scheme" means the scheme of forestry operations referred to in section four:
- "The Trust Account" means the account to be kept in the Treasury pursuant to section five.

# Power of Treasurer to borrow £5000.

3 It shall be lawful for the Treasurer to raise, borrow, and receive, for the purposes of this Act, any sum or sums of money not exceeding in the whole the sum of five thousand pounds.

#### Forestry scheme to be carried out by two trustees.

4 The scheme of forestry operations referred to in the Preamble to this Act as having been approved by the Federal Treasurer, the general particulars of which are set out in the schedule, shall be carried out under the general direction of two trustees (hereinafter called "the trustees"), one of whom shall represent the Commonwealth and the other shall represent the State. The trustee to represent the State shall be the Conservator of Forests, and he shall act as a trustee in conjunction with the trustee appointed by the Commonwealth as its representative.

#### Trust Account.

5—(1) There shall be opened and kept in the books of the Treasury a trust account to be called "The Commonwealth Aid to Forestry Trust Account."

## Aid to Forestry (Federal Grant).

- (2) All moneys received from the Commonwealth under the pro- A.D. 1935. visions of section nine of the Commonwealth Act shall be paid into and credited to the Trust Account.
- (3) There shall also be paid into and credited to the Trust Account all moneys borrowed and raised by the Treasurer under this Act.
- (4) The Treasurer shall pay and apply the moneys from time to time Application of standing to the credit of the Trust Account for the purpose of carrying moneys. out the forestry scheme in accordance with the conditions approved by the Federal Treasurer.

- (5) No payment shall be made out of the Trust Account except on a certificate signed by the trustees.
  - 6 The Governor may make regulations for the purposes of this Act. Regulations.
