AN ACT to amend "The Albert Henry Jackson Pension Act 1931." [18 November, 1948]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Albert Henry Jackson Pension Act 1948.
- (2) "The Albert Henry Jackson Pension Act 1931*" is in this Act referred to as the Principal Act.

Grant of pension to Albert Henry Jackson.

2 Section two of the Principal Act is amended by omitting from subsection (1) the words "Two hundred and sixty" and substituting therefor the words "three hundred and twenty-five".

BANK HOLIDAYS.

No. 45 of 1948.

AN ACT to amend the Bank Holidays Act 1919. [15 December, 1948.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Bank Holidays Act 1948.
- (2) The Bank Holidays Act 1919*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section four of the Principal Act is amended—

Bank holidays.

- (a) by omitting the proviso to paragraph II. of subsection (1) and substituting therefor the following proviso:-
 - "Provided that when New Year's Day falls upon a Saturday or a Sunday the following Monday shall be a bank holiday and shall, for the purposes of section eleven, be deemed to be the day on which New Year's Day is publicly observed:";
- (b) by omitting the proviso to paragraph III. of subsection (1) and substituting therefor the following proviso:
 - "Provided that—
 - I. When Christmas Day falls upon a Friday, the following Monday shall be a bank holiday and shall, for the purposes of section eleven, be deemed to be the day on which Christmas Day is publicly observed: and
 - II. When Christmas Day falls upon a Saturday or a Sunday the following Monday and Tuesday shall be bank holidays and shall, for the purposes of section eleven, be deemed to be the day on which Christmas Day and the day after Christmas Day respectively are publicly observed:"; and
- (c) by adding at the end of subsection (1) the following paragraph:—
 - "VIII. The anniversary of the birthday of His Majesty, which shall be observed on such day in each year as the Governor may appoint for that purpose.".
- 3 Section eleven of the Principal Act is amended by adding Interpretation of at the end thereof the following subsection:—
- "(2) Where, in any wages board determination or indus-in certain agreement trial agreement or any agreement relating to work, made to public holidays. either before or after the commencement of this Act, any reference is made to-

reference

- I. A day observed in lieu of, or in substitution for, any bank holiday (whether such bank holiday is therein referred to as a holiday, or a public holiday, or a bank holiday); or
- II. A day on which any bank holiday (whether such bank holiday is therein referred to as a holiday, a public holiday, or a bank holiday) is generally or publicly observed, either throughout the State or in any locality.

such reference shall be read and construed as a reference to the day on which such bank holiday is publicly observed.".
