# AN ACT to amend the Bank Holidays Act 1919.

## [Royal Assent 23 December 1987]

**B**<sup>E</sup> it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Bank Holidays Amendment Short title. Act 1987.

Commencement.

2—This Act shall commence on the day on which it receives the Royal assent.

Principal Act.

3—In this Act, the Bank Holidays Act 1919\* is referred to as the Principal Act.

Insertion in Principal Act of new section 2. 4—After section 1 of the Principal Act, the following section is inserted:—

References to certain awards.

2—A reference in this Act to an award made by the Tasmanian Industrial Commission under the *Industrial Relations Act 1984* includes a reference to a variation under that Act of such an award.

Amendment of section 4 of Principal Act (Bank holidays).

- 5—Section 4 of the Principal Act is amended as follows:—
  - (a) by omitting paragraph (i) of subsection (1) and substituting the following paragraph:—
    - (i) Saturday, subject to subsection (1A).
  - (b) by inserting the following subsection after subsection (1):—
    - (1A) A reference to a public or bank holiday in—
      - (a) an award or order made, or an industrial agreement approved, by the Tasmanian Industrial Commission under the Industrial Relations Act 1984; or
    - (b) any other agreement relating to work, whether made, or, as the case may be, approved, before or after the commencement of the Bank Holidays Amendment Act 1987, shall not be deemed to be a reference to a day on which banks are required to be closed under subsection (1) (i).

Amendment of section 11 of Principal Act (Interpretation of reference in certain awards, &c., to holidays, &c.).

- 6—Section 11 of the Principal Act is amended as follows:—
  - (a) by omitting subsection (1) and substituting the following subsection:—
    - (1) Where in-
      - (a) an award or order made, or an industrial agreement approved, by the Tasmanian Industrial Commission under the Industrial Relations Act 1984; or

- (b) any other agreement relating to work made, before or after the commencement of the Bank Holidays Amendment Act 1987, reference is made to a holiday, public holiday, or bank holiday, that reference shall be deemed to relate to the day on which that holiday is publicly observed under this Act.
- (b) by omitting from subsection (2) the passage beginning with "any wages" and ending with "made to—" and substituting the following passage:—
  - "an award or order made, or an industrial agreement approved, as mentioned in subsection (1) (a), before or after the commencement of the Bank Holidays Amendment Act 1987 or in any other agreement relating to work made before or after that commencement, a reference is made to—";
- (c) by inserting "under this Act" after "publicly observed", where lastly occurring.
