BRACKNELL WATER.

No. 40 of 1958.

AN ACT to amend the *Bracknell Water Act* 1906. [14 October 1958.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Bracknell Water Act* 1958. Short title citation, and commencement.

(2) The *Bracknell Water Act* 1906, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the first day of July 1958.

2 Section thirty-four of the Principal Act is repealed and the following section is substituted therefor:—

"34 The rate referred to in section thirty-three shall be called a water rate, and may be of an amount not exceeding the sum of four shillings and sixpence per annum on the assessed annual value of the property within the District, and, except as otherwise provided in this Act, all the provisions of the *Local Government Act* 1906, and the *Rates and Charges Recovery Act* 1936, relating to the making, publication, levying, collecting, and recovery of rates apply to the making, publication, levying, collection, and recovery of every rate imposed under the authority of this Act; and where the trustees levy a water rate they may, at the same time, fix a minimum amount to be paid in respect of properties within the district, but the minimum amount so fixed in respect of any property shall not exceed—

I Fourteen pounds in respect of any house or dwelling:
or

II Four pounds in respect of any vacant allotment of land,

as may be decided by resolution of the Trustees from year to year."

3 Schedule (1) to the Principal Act is repealed and the following schedule is substituted therefor:—

“ SCHEDULE (1).

“ BRACKNELL WATER DISTRICT.

“ Bounded on the north by seventy-three chains or thereabouts westerly along land granted to Paul Minnett commencing at the River Liffey on the west by ten chains sixty links southerly along Lot 1 Section P purchased by William Saunders again on the north by fourteen chains twenty-five links or thereabouts westerly also along the last-mentioned lot and along part of Lot 2 Section P purchased by Balthaser Hertel again on the west nine chains sixty-eight links southerly crossing Louisa Street and along Lot 2 Section W purchased by Joseph Wadley on the south by thirteen chains twenty-five links easterly along Jane Street again on the west by ten chains ninety-two links southerly crossing Jane Street and along Lot 1 Section U purchased by John Baker again on the south by sixty chains or thereabouts easterly along other land granted to Paul Minnett to the River Liffey aforesaid and thence by that river to the point of commencement.”.

CARRICK WATER.

AN ACT to amend the *Carrick Water Act 1947*.
[14 October 1958.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Carrick Water Act 1958*.

(2) The *Carrick Water Act 1947*, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the first day of July 1958.

Water rate.

2 Section twenty-three of the Principal Act is amended—

(a) by omitting from paragraph (a) of subsection (1) the word “ five ” (first occurring) and substituting therefor the word “ fourteen ”; and

(b) by omitting from paragraph (b) of that subsection the words “ one pound ” (first occurring) and substituting therefor the words “ three pounds ten shillings ”.
