## PUBLIC AUTHORITIES' LAND ACQUISITION (No. 2)

# AN ACT to amend the *Public Authorities' Land Acquisition Act* 1949. [7 December 1967.]

B<sup>E</sup> it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Public Authorities' Land Acquisition Act (No. 2) 1967.
- (2) The Public Authorities' Land Acquisition Act 1949, as subsequently amended, is in this Act referred to as the Principal Act.

Interest on compensation.

- 2 Section thirty of the Principal Act is amended—
  - (a) by omitting from subsection (1) thereof the word "four" (first occurring) and substituting therefor the word "five"; and
  - (b) by omitting from subsection (2) of that section the word "one-third" and substituting therefor the word "five-twelfths".

### CONSTITUTION.

### No. 54 of 1967.

AN ACT to amend the Constitution Act 1934.

[7 December 1967.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Constitution Act Short title and citation. 1967.
- (2) The Constitution Act 1934, as subsequently amended. is in this Act referred to as the Principal Act.
- 2 Section thirteen of the Principal Act is amended by omittings of ting from subsection (2) thereof the words "such proclamation" and substituting therefor the words "a proclamation under subsection (1) of this section".
- 3 Section nineteen of the Principal Act is amended by Council omitting from subsection (4) thereof the word "second" and elections. substituting therefor the word "fourth".
  - 4 Section thirty-three of the Principal Act is amended—
    - (a) by inserting in paragraph (ca) of subsection (3) thereof, after the word "loan" (first occurring), the words " or a Closer Settlement Board loan"; and
    - (b) by inserting in subsection (6) thereof, after the definition of "agricultural operations", the following definition:—
      - "'Closer Settlement Board loan' means any loan or advance made by the Closer Settlement Board under or for the purposes of any Act;".
  - 5 Section thirty-seven of the Principal Act is amended—Money Bills to originate (a) by inserting in subsection (1) thereof, after the in the Assembly

- word "revenue", the words "or of any moneys"; and
- (b) by inserting in subsection (2) thereof, after the word "revenue", the words "or of any moneys".
- 6 Section thirty-eight of the Principal Act is amended by All money inserting therein, after the word "revenue", the words "or recommended of any moneys".

7 Notwithstanding any other law, the Members of the Transitory Council who are required under the Principal Act to retire at the periodical elections to be held in the month of May 1968 shall hold office, subject to that Act, until the day preceding those elections, and the remuneration payable to those members under the provisions of the Parliamentary Salaries and Allowances Act 1962 shall be calculated and paid accordingly.
